Required

Materials: (1) Allen Cadwallader, David Gagné, Frank Samarotto. *Analysis of Tonal Music: A*

Schenkerian Approach, 4th ed. (New York/Oxford: Oxford University Press, 2020). Text

only. [Note: You will need the 4th ed. Earlier editions will not do.] (2) Handouts. Put them in a binder or folder and bring to each class.

(3) Music paper and pencil, or computer/tablet notation program.

Course content: This course offers a practical introduction to the analytical methodology developed by

Heinrich Schenker (1868-1935). The coursework will consist of the following:

(1) Graphic analyses (called *graphs* or *sketches*) of excerpts, complete movements, and short pieces from the tonal repertory (approximately 1700-1900) starting with relatively short assignments and gradually increasing the length and complexity of the material. I will provide copies of the scores to be studied, or will place them on Canvas. There will be reading assignments in the Cadwallader-Gagné text, but the bulk of the work will be your own written analyses, and most class discussion will be about the music we analyze.

(2) Readings in the Cadwallader-Gagné text and, perhaps, some articles and excerpts.

Grades: Homework 100%

Grades are based on quality and quantity of homework, regular attendance, and participation in classroom discussions. In this subject, "getting the right answer" is not the point. You will not get a low grade if your analysis of a piece is different from mine,

as long as yours makes sense and is presented clearly.

<u>Homework</u>: Written homework will be due several times per week. <u>Please do the HW on paper and</u>

give it to me in class, or shove it through the slot in my office door. Homework must be handed in on time to receive full credit, as we will go over the pieces in class, which will make it difficult for you to do original work on them afterwards. And since the homework serves as preparation for the class discussion, I won't accept homework after we have gone over it in class. Make a copy of your homework for yourself before

you hand it in so you can refer to it during class discussion.

If you miss class for a valid reason, you will be able to turn your homework when you are

able to return to class.

If we haven't yet gone over the assignment in class, late work will be graded down a full letter grade and not accepted after two classes past the due date. Excuses for late

homework will be considered only if you contact me in a timely fashion, that is: <u>before or</u> <u>on the date the homework is due</u>, or at the latest at the very next class session.

Absences:

Excused: Absences are excused for illness, natural disasters, transportation problems beyond your control, and College of Music activities. For the latter,

are responsible for informing me—don't assume that I'll get an email with a list of excused students. Sometimes I do, sometimes I don't. If you feel that an absence for any other reason should be excused, discuss it with me; don't assume that I will or won't accept it: leave that decision to me. For all excused absences I must be informed at the latest within a week after the missed class.

Unexcused:

You are allowed 4 unexcused absences. Every additional unexcused absence deducts 2 points from the final course grade (100 total). I will take attendance at the beginning of each class. If you arrive after I've done so, it's your responsibility to make sure you are marked as present before you leave the class room. otherwise, you'll be marked absent. Keep track of your absences; if you're unsure, ask me. Equally, if you're unsure whether I marked you present, check with me on your way out of class, or soon afterwards. In cases of disputes, I go by my records. Unexcused absences will be listed on Canvas (Grades). Canvas doesn't include them in your class average; I do that when I calculate final grades. It is important to be careful about unexcused absences, because they tend to accumulate fast. For instance, 6 unexcused absences would be 4 points off the course grade.

If you miss a class, you are still responsible for the assigned homework and for knowing what was covered in class. Get the information from me or another class member. Generally the best way to contact me is through email. Assignments will be posted on Canvas.

Plagiarism:

Since the course grade is based almost entirely on individual assignments, it is essential that those assignments represent your own work, not someone else's. Do not do homework collaboratively. To clarify: you can discuss assignments with others, in a general way, beforehand. But once you put pencil to paper, your work must be your own. If I see convincing evidence of plagiarism, I will talk to the people involved. Evidence of plagiarism will result in an automatic grade of "0" on the assignment and will be reported to the Dean of Students.
