<u>Class mode</u>: In-person only.

Materials: Required text: Salzer, Felix and Carl Schachter, Counterpoint in Composition. New

York: Columbia U.P, 1989. Bring to every class.

Assorted handouts. All handouts will be posted on the Canvas **Documents** module. Bring

to each class.

Music paper and pencil.

Access to Canvas is required.

Course description and objectives:

This course will focus on writing *species* (also called *strict*) counterpoint in two and three parts, organized as follows: 1st though 5th species, each in two and three voices, followed by combined species in three parts. We may also look at Beethoven's counterpoint exercises for his teacher Haydn, and read in contrapuntal sources such as Fux's *Gradus ad Parnassum* and Heinrich Schenker's *Counterpoint*. However, this is predominantly a writing course.

Short written assignments will be due at virtually every class. Student homework (unattributed) will sometimes be put on the board for group appraisal and suggestions. We may also write in class, both individually and in small groups, but Covid distancing protocols may prevent or modify that. It is important that you are able to



what you write--it is of little value to put notes on paper without knowing what they sound like. If you can accurately hear your counterpoints internally, well and good, but usually people can do this only imperfectly. The skill improves with practice. Try your best to hear internally, especially when you must write without reference to an instrument or voice (as in tests). Otherwise, always **play** your counterpoints before turning them in.

Assignment Protocols

Every assignment must (1) contain your name and the **due date** at the top of the page, and (2) be written or printed clearly and legibly. My procedure is usually to print out your HW from Canvas, mark it up, rescan it, and send it back. I have to be able to read your

HW. Scans are best. There are available scan apps you can use on your phone. If you send me photos of HW, be sure that they're neither too small or dark, and that no shadow falls across them, or they will be too dark to read when printed. There are various apps that will convert a photo into a scan. Please put all HW in PDF or JPEG format, or I probably won't be able to see it. I usually comment extensively on HW; I compile a numbered list of faults, comments, & suggestions. For instance: #3 might be "although labeled a PT, it's NOT a PT"; #19 might be "illegal 6/4 chord," etc. The comment keys change for each HW, but involve a lot of repetition, since people keep repeating the same mistakes over and over again. In general, if a student ignores the comments and simply repeats the same faults *ad infinitum*, I deduct more and more from the grade.

I do not use a metric for grading HW. Metrics don't work for counterpoint—there are too many contextual variables. I play through each assignment, comment on it, and then assign what seems to me a fair grade.

Please submit homework via Canvas. Go to the assignment (in **Assignments**). **Submission type** should already be set to **file upload**, which will allow you to upload a scan, photo (see comments above re format), or other file of your work. Late work:

Assignments are due at the class period on the assigned date. Late assignments will be graded down a full letter grade and accepted no later than one class after the due date. Excuses for late homework will be considered only if you contact me before or on the date the homework is due, or at the latest at the very next class session. Whether I accept your excuse is up to me. After that time period, no excuse will be considered unless you tell me why it was not possible to contact me before. However, if you have an excuse for late homework, don't neglect to tell me what it is, on the assumption that I won't accept

it. Leave that decision to me.

Absences:

Excused:

Absences are excused for illness, natural disasters, transportation problems beyond your control, and official College of Music musical activities. For the latter, you are responsible for informing me-don't assume that I'll get an email with a list of excused students. Sometimes I do, sometimes I don't. If you feel that an absence for any other reason should be excused, discuss it with me; whether I accept it or not is my decision. Don't assume that I will or won't accept it: leave that decision to me. For all excused absences I must be informed at the latest by the next class session.

<u>Unexcused</u>: You are also allowed 3 unexcused absences. Every additional unexcused absence deducts 3 points from the final course grade. I will take attendance at the beginning of each class. If you arrive after I've taken attendance, IT'S YOUR RESPONSIBILITY TO MAKE SURE YOU ARE MARKED AS PRESENT BEFORE YOU LEAVE THE CLASS ROOM, OTHERWISE, YOU WILL BE MARKED ABSENT. Keep track of your absences; if you're unsure, ask me. Equally, if you're unsure whether I marked you present, check with me on your way out of class, or soon afterwards. In cases of disputes, I'll go by my records.

> If you miss a class, you are still responsible for the assigned homework and for knowing what was covered in class. Get the information from me or another class member. Generally the best way to contact me is through email (stephen.slottow@unt.edu).

Undergraduates
