Course Description

This course is designed to introduce students to global public health. In this course, students will become familiar with the work done in global health to address transnational health issues impacting populations across the world. Students will explore health outcomes and the forces that impact health in different countries and regions of the globe. Students will become familiar with global health priorities and the public and private organizations working to address them. The course will emphasize the interplay between social, cultural, economic, political, and environmental factors that impact health and disease at the global level. Throughout the course, students will hear from people active in addressing global health issues.

Course Structure

The course format and content delivery for PUBH 3030.003, Fall 2022, would be Face-to-Face for 16 weeks.

- Identify global health priorities
- Detail the key concepts of global health
- Understand the differences in health across the globe
- Identify what health means to people in different parts of the world
- Understand the impact local, national, and transnational political and economic forces have on the health of local communities.
- Describe the role culture plays in health behavior
- Identify the ethical dilemmas involved in global health decision making
- Detail ways to identify local and national resources to improve health
- Understand the importance of cultural awareness when planning, implementing, and evaluating health initiatives.

- Proofread and fact-check your sources.
- Keep in mind that online posts can be permanent, so think first before you type.

Quizzes

Students are required to complete weekly quizzes in Canvas. The quizzes will include questions from the material presented the same week. Each quiz will be posted Monday and students will have until Sunday at 11:59pm of the same week to complete the quiz. Quizzes can only be taken once. A student may be able to make up quizzes depending on the situation. The two lowest grades will be dropped at the end of semester. In total, quizzes will account for 200 points earned for the course.

Participation

Students are required to complete the readings assigned in the textbook and review the supplemental material presented the same week. Students are required to attend class in person. Weekly participation is worth 10 points each week, adding up to 150 points for the semester.

Project 1

Students will be put into groups of 3-4. Students may also opt to do the project alone. Students will choose a country and detail specific factors that impact the health of the population. Students will include one current event that is impacting the health in the country. In addition to submitting the report, students will critique their groupmates. Details are posted in Canvas.

Project 2

Students will be put into groups of 3-4. Students will choose two countries and detail specific factors that impact the health of the population. Students will detail the differences between the two countries and explain why differences exist. In addition to the report, students will critique their groupmates. Details are posted in Canvas.

Final Exam

Students will be tested over information presented throughout the course. Questions will be taken from the weekly quizzes. The final exam will be worth 20% of the final grade. A review of quiz questions will be held before the final becomes available.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email internationaladvising@unt.edu) to get clarification before the one-week deadline.

Student Verification

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students'
