COURSE DESCRIPTION

This course is designed to introduce students to social, ideological, economic, and political forces that influence health policymaking. The course will involve an examination of the US health care system and the role of key players in health policymaking. Students will become familiar with the policymaking process and ways to impact the process. The course will familiarize students with the legal system and the vital role it plays in the debate, creation, and implementation of health policy. The course will also focus on essential factors in health policy including inequality in health, access to healthcare, the economics of health policy, healthcare reform in the United States, and public health preparedness.

COURSE OBJECTIVES

By the end of this course, students will be able to:

- 1. Understand the concepts of health policy and policymaking
- 2. Describe the legal system and legal concepts that impact health policy
- 3. Discuss the ethical dimensions of healthcare and public health policy
- 4. Analyze the impact health policy has on disparities in health, access to care, and healthcare costs
- 5. Understand the responsibilities of different agencies and branches of government
- 6. Discuss federal health insurance programs and their impact on health
- 7. Detail the differences between public and private health insurance
- 8. Understand health care economics and its relationship to health policymaking
- 9. Discuss the main perspectives and methods used to examine healthcare policy
- 10. Understand the relationship between politics, research, and health policy

COURSE REQUIREMENTS

There are five ways I assess a student's performance in this course. Students must complete the reading assigned in the textbook and the supplemental readings each week and actively participate in the weekly presentations. Students must also participate in weekly discussions with the class. Students will complete three assignments - a policy fact sheet, a policy brief, and a policy analysis paper. Participation

Students are required to complete the readings assigned in the textbook and review the supplemental material before class. Participation points are earned by attending class each week and answering required class material questions in-class every Friday. Weekly participation is worth 10 points a week which adds up to 150 points total for the semester. Please reach out to me if you are not able to attend any class.

Discussions

Students are required to participate in weekly discussions worth 20 points each. Discussions will become available by Thursday of each week. Students are required to complete the following weekly:

Each Friday by the end of class (1:50pm) – post your response to the discussion question/s (15 points each week)

Each Sunday by 11:59pm - comment on a fellow student's post (5 points each week)

Policy Fact Sheet

Students will complete a 1 to 2-page policy fact sheet worth 100 points. See Canvas for more details.

Policy Brief

Students will complete a three to four-page policy brief. The policy brief is worth 200 points. Due dates are listed in the calendar. See the Policy Brief Guidelines and Rubric for more details.

Policy Analysis

Students will complete a six to seven-page policy analysis. The Policy Analysis is worth 250 points. See the Policy Analysis Guidelines and Rubric on Canvas for more details.

LATE WORK POLICY

Any work submitted after the deadline will lose points. All assignments are set to close in Canvas 24 hours after the deadline. Once an assignment or exam is closed you may not submit work. Please contact me if you have any issues meeting a deadline.

GRADING

All of the components of a student's grade will have a point value system, based on an A being equivalent to a 4.0. Points will be given based on a student's performance, such as the quality of information posted in the weekly discussions, writing skills, research skills, and ability to illustrate comprehension of all course topics. Each assignment will include a rubric for specific details on grading criteria.

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the Electronic Code of Federal Regulations website (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G). The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken online or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An online or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no online or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

- Proofread and fact-check your sources.
