Class Distraction:

- -No food or drink allowed in the classroom

Attendance affects your grade:

Attendance Policy:

Attendance is required at all sessions.

- 1. Students should give notice if they cannot attend a lesson. Notify your professor by making a phone call, text or email with an excuse coming from the Health Center or your doctor within 48 hours after missing class.
- 2. Failure to notify your professor will affect the final grade.
- 3. The student will be allowed one absence per semester.
- 4. Repeated tardiness will result in the reduction of the final grade. You have to be on time like on any gig.

<u>Undergraduates</u>

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program.
