## **Course Description**

This course will cover the key basic concepts from a range of disciplines including finance, managerial and financial accounting, and project accounting. The concepts will cover discounted cash flows, net present value, cost of capital, sensitivity analyses, risk (expected monetary value, decision tree analysis,) account statements, balance sheets, ratio analysis, liability and asset identification, cost management, project monitoring, earned value management, and cost recognition approaches. The course objective is to provide students with an understanding of tools, techniques, and practices in business to strengthen their project managing skills. The course will help students to develop skills in business research and strategy, portfolio and project alignment, and equip them with fundamental knowledge required for entrepreneurship
