Goals

The three major goals of this course are:

- 1. to become familiarized with the most often requested orchestral excerpts for bass and tenor trombone.
- 2. to receive guidance in the correct technical, stylistic and musical preparation of these excerpts.
- 3. to become informed the of musical and pedagogical sources of trombone excerpt material.

Class Format and Expectations

Students will participate in class by preparing and performing the required excerpts and offering constructive feedback on the in-class performance of their peers when prompted to do so. Instruction will consist of lectures, demonstrations and class discussions. Attendance is required. Each unexcused absence will result in the lowering of the final letter grade by one letter. The final exam for this class will be a mock audition at the end of the semester. The date for this exam will be finalized near the end of the semester.

Assignments and Papers

The class will be assigned a different excerpt each week, with some excerpts possibly receiving two class sessions of instruction. Below is a list of the excerpts that will be covered in class and their projected dates (subject to change):

Financial Aid and Satisfactory Academic Progress

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

Graduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on

total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
