SYLLABUS Trombone Choir University of North Texas

Objectives

The objectives of trombone choir are

1. to develop reading, ensemble performance and chamber music skills to a high level through the performance of trombone ensemble music.

- 2. to expose students to the trombone ensemble repertoire.
- 3. to extend the objectives of applied music through additional trombone performance.
- 4. to give at least one performance per quarter.

Attendance

Attendance is required. Unexcused tardiness or absences result in lowering of the quarter grade (see Evaluation section below). Tardiness or absences caused by illness, emergency, certain College of Music functions, or unavoidable difficulties *which seem reasonable* are excused if the instructor is notified as soon as possible. A rehearsal or performance missed due to illness requires a doctor's excuse. **Chronic absence will result in a lowered or failing grade.**

Evaluation

If all of the following requirements have been met, the student receives an A for the quarter:

- 1. The music has been prepared to the best of his/her ability.
- 2. The student has been consistently prompt for and in attendance at rehearsals and performances.
- 3. The student has maintained a positive and professional attitude throughout the quarter.

The following grade deductions are applied to these <u>unexcused</u> situations:

- 1. After a student is tardy two times, his/her grade is lowered from A to B. After 4
- times the grade becomes C. After 6 times, D. After 8 times, F.

2. Each unexcused rehearsal absence results in the lowering of the grade by one letter: A to B etc.

3. A missed performance results in an F.

4. If the student is habitually unprepared, the teacher may lower the grade one letter grade.

Preparation

Students are required to prepare their parts outside of rehearsal time. Rehearsals are designed to polish the musical aspects of performance such as style, phrasing, intonation and balance.

By being a member of a trombone choir, you are all doing one of the best things you can do to shape and polish your development as trombonists. Those of you who are unfamiliar with this genre will probably be surprised by the expressiveness capable by a group of these instruments. In short, we know you will all be glad you were members of this ensemble. Please feel free to contact me with any problems or concerns about this ensemble. Have a great semester!!

Financial Aid and Satisfactory Academic Progress

<u>Undergraduates</u>

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so. <u>Graduates</u>

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
