## **Course Overview**

## **Course Description**

This course is designed to accompany the CHEM 1410 General Chemistry I lecture course. Many of the topics covered in this course will have direct correlation with the topics covered in CHEM 1410. However, there may be times when the laboratory course is "ahead" of the lecture course. It is your responsibility to read all material presented on Canvas so that you can complete the assignments and experiments successfully.

While I want to make myself as available as possible to each of you, I do have to place some limitations on when I can be contacted. I would prefer that most general questions go through the Q & A forum in the Discussion Board area. If you have a general question about the course or assignments, please post it there. Either your TA, one of your classmates, or I will answer it there. This way we can all benefit from questions asked, and they can be answered in a venue that the whole class can see. You may also want to find someone in class to be a "buddy" with. This will give you at least one other person who you can email with questions.

If you have a private question, please contact me via email only and I will respond within 24 hours on weekdays (usually sooner). Please do not expect a response over the weekend. DO NOT use Canvas Inbox to contact me directly. I do not receive those notifications regularly and your message will get lost. Email me directly for a quick response.

When emailing your Instructor or TA, you MUST include your Full Name, Course Number, and Section Number in order to receive a response. There are 60 sections all with over 20 students each. If you do not give me that information, I do not have the time to find you in all of those sections, so I will not look.

My primary means of communication with the entire class will be through the Announcements feature of Canvas. Your TA will also be utilizing this feature for mass communications throughout the semester.

## **Prerequisites**

• Either concurrent or previous enrollment in CHEM 1410 (or equivalent course if transferring from another institution) is required.

• CHEM 1430 is a separate course from CHEM 1410. If you drop one course, you are not automatically dropped from the other.

## Required Texts

There is no required textbook for the course. All material will be presented on Canvas.

### **Course Structure**

This course takes place mostly online. Your instruction will primarily be performed here on Canvas. All assignments will be submitted for grading on Canvas. In-person experiments will be expected to be completed on the day and time assigned to you. Your TA may provide additional instruction in the laboratory room as needed in order to successfully complete that week's experiment.

Within the first week of classes, your lab section will be randomly split in half to form Group 1 and Group 2. Your group assignment will determine what experiment or simulation you are working on each week. Both Groups will complete the same assignments every two weeks, you just will be on different schedules. For example, one week, Group 1 might be performing an in-person experiment while Group 2 is performing a simulation. The following week, Group 1 will perform the simulation while Group 2 completes the in-person experiment. Before each assignment Module, there will be a weekly Overview module on Canvas that will explain what each Group is expected to complete that week. These Overview modules will unlock the Friday before each week.

All in-person experiments will need to be completed on the day and time you have been assigned for your Group. Because of the large number of students enrolled in CHEM 1430, we cannot guarantee a time for you for you to come in and make up the missed experiment. If you need to make up an experiment, please email the Instructor (not your TA!!) and he will get you an appropriate make-up assignment. Prelab quizzes will need to be completed before 11:59 pm the night before your scheduled in-person experiment. It is recommended that these be completed before you come to the laboratory. The Data Submission and Postlab question(s) for each in-person experiment will be due one week after you complete the experiment.

Simulations will open at 12:00 am until 11:59 pm the day of your scheduled lab class. If you do not complete the simulation before it closes, you will not receive a grade for that assignment.

# Course Objectives

Upon successful completion of this course, learners will be able to (numbered in order of presentation):

- 1. Analyze data using statistical methods in Excel.
- 2. Demonstrate the ability to prepare a chemical solution at a given concentration.
- 3. Evaluate a chemical procedure by analyzing the percent yield of a reaction.
- 4. Analyze bond angles and bond lengths for simple molecules using computational methods.

- 5. Compare the empirical formulas of simple compounds to known formulas and evaluate sources of error in an experimental design.
- 6. Identify unknown elements based on their stoichiometry in a reaction.
- 7. Compare the molar mass of a gas based on experimental results.
- 8. Apply the principles of the Ideal Gas Law towards the development of a new temperature scale.
- 9. Interpret heat curve data to separate two liquids via distillation.

# Course Activities & Assignments

# Labster Simulations (500 points)

Labster Simulations will be worth 100 points each. Each simulation will consist of questions that must be answered correctly in order to continue through the simulation. Each time you get a question wrong in Labster, points will be deducted from your overall score. You will be allowed to complete the simulation as many times as needed to boost your score, but be warned that in order to boost your score you must complete the entire simulation again. It is recommended to try and get as best of a score as possible the first time that you complete the simulation. All background materials for the simulation are provided within the simulation.

• There are five Labster simulations for a total of 500 points at the end of the semester.

# Alternative Assignments for Students with Disabilities (500 points)

These assignments are for students who cannot access Labster due to disability restrictions and appropriate documentation from ODA. For these students, you will be assigned an in-person experiment equivalent to the Labster simulation to be performed during your regular lab meeting day and time. Grading for these experiments will consist of three sections for a total of 100 points per experiment.

- Data Submission: 90 points each
- Safety and Cleanup in the laboratory (to be assessed by your TA when you are performing the experiment): 10 points each

## Experiments (500 points)

There will be five experiments that need to be completed in person in your assigned laboratory room on your assigned week. Grading for each experiment will consist of four sections for a total of 100 points per experiment.

- Prelab Quiz (to be completed after reading the Introduction and watching all videos on Canvas):
  15 points each
- Data Submission: 50 points each

- Postlab Questions (will unlock on Canvas after you have submitted your Data): 25 points each
- Safety and Cleanup in the laboratory (to be assessed by your TA when you are performing the experiment): 10 points each

## Geometry Activity (100 points)

The Geometry Activity will need to be completed at your discretion using the computers available in CCIL (Chemistry 232) and the Gaussview program. The Geometry Activity will be graded based on the following items

- Prelab Quiz (to be completed after reading the Introduction and watching all associated videos on Canvas): 15 points
- Data Submission: 50 points
- Postlab Questions (will unlock on Canvas after you have submitted your Data): 35 points

# Grading

Grading is based on the total points earned throughout the semester. The percentages listed on Canvas will always be an incorrect representation of your grade in the course.

### **Course Policies**

#### Late Work

I will not accept late work in this course. All work turned in after the deadline will receive a grade of zero unless the student has a <u>university-excused absence</u> and provides documentation with 48 hours of the missed deadline.
