Required Materials

We will be using a textbook (and a few other short readings) accessed through a platform/app called "Perusall." There is a page in Canvas that provides step by step instructions for accessing the textbook and other readings. When you sign up for Perusall and join our "class" there, you will be prompted to pay approximately \$10. The \$10 is a licensing fee for the textbook readings. It is NOT a fee to use Perusall or a payment for any readings written by your instructor.

If you want to have a full copy of the textbook we are using (one that isn't dependent on an internet connection), you have two options.

You can order a print copy (\$20.07 to rent from Amazon) or download a copy from the Internet if you prefer not to read on a screen. If you wish to order a print copy, the ISBN is 978-1-711493-95-4.

Why This Course Matters to You

This is a course about action. In the political science world, we call it "political behavior": how the behavior (actions) of individuals and groups come together to form the political landscape. It is also a course about power. It is a course about the power that forces such as the media and interest groups hold over you. But it is also about your power—and the power of people like you—to create the political policies you want to see.

Many students say that politics doesn't matter to them. But think about the things that do matter to you. Maybe that is school and the federal student loans that allow you to attend. Maybe that is immigration and the effect that has on your family. Maybe that is whether you will have a job when you graduate or whether you will be able to support your family with the money you make from that job. All of those things are affected by politics. If you care about those things, you care about politics, and you need to understand how you and other institutions come together to create those policies.

Course Objectives

Students who complete this course will be able to

- explain the development and measurement of individual values, attitudes, and opinions about politics;
- interpret the role of individuals in the political process;
- explain the roles of linkage institutions (parties, interest groups, and media) in connecting individuals to institutions of government;
- demonstrate the relationship between electoral rules/institutions and outcomes; and
- explain the connection between the political process and the policies generated by that process.

Graded Assignments

Perusall Assignments

Perusall is a platform designed to support deeper and more collaborative learning. You will create an account with Perusall; pay \$10 to access our course materials through the platform; and do your reading through that site. As you read, you can annotate the text. You can offer definitions, pose questions, provide links to relevant news stories . . . there are many ways to turn the text into a richer, more personal document. As you comment, other members of the class can see your annotations, add their own, respond to your questions, and "upvote" your observations.

Perusall uses an algorithm to grade your performance on each assignment (each "chunk" of reading). That algorithm gives you credit for the time you spend working on the reading, the number and quality of comments, and your engagement across the full length of the assignment. As you work, you can view your Perusall score to make sure you are getting up to full credit.

There is a Perusall assignment for each of the nine course modules. Perusall assignments are typically due at 11:59 PM on Sundays. The exception is the LAST Perusall assignment (covering foreign policy) which you must complete before the final exam.

Quizzes

In order to check your progress as the course progresses, you will take a total of four quizzes, each due at 11:59 PM on Sunday. Each quiz will cover the two modules for the preceding week. These quizzes, taken in Canvas, are open book and open note, but they are timed. (You have one hour to complete the quiz unless you have additional time to accommodate a disability.) These quizzes are not intended to trick you or make your life difficult. They are meant to make sure that you are following the course content and keeping up so that you will be prepared for the final exam when it rolls around.

Final Exam

There is a single final exam in this course. It will be administered via Canvas, and you will need to take it in the Sage Hall Testing Center or in the Office of Disability Accommodation. Your time limit to take the exam is 60 minutes (unless you qualify for extended time). The exam will be administered between 10 AM and 12 PM on Thursday, June 22. Note that the exam availability ENDS at 12, noon, so you need to plan your start time accordingly. If you have extended time for the exam, you will need to arrive for the exam no later than 10:30 AM.

Attendance and Late Policies

You are expected to attend class. You need to arrive on time and plan to stay until the end of class. (We will take a 10 minute break in the middle of each class, and if you need to use the restroom or take a moment to yourself, you can leave and come back. However, you should not come and go a great deal, as it is distracting.) Arriving after 10:15 is the equivalent of an absence. You get one free pass (an absence that does not affect your grade) After that one "free pass," every absence from class will result in a 20 point (2%) reduction from your final course score.

There is a grade column in Canvas that tracks the number of absences you have.

What happens if you get COVID? If you develop COVID and will need to isolate at home, we will create a system for you to attend class via Zoom. That includes participating with your team via Zoom. This is not ideal, so I will not do this for things like vacations, but we will go the extra mile to keep everyone safe. Let me know ASAP if you need to isolate at home for more than 2 days.

Grade Disputes

If you believe that you have received an unfair or inappropriate grade, you must notify me within one week of the grade posting on Canvas. You should notify me *in writing* of your concern. You need to explain to me, in writing, which assignment you are concerned about and why you feel your grade should have been higher. We can then schedule a time to talk about the issue if necessary. I make mistakes, and I will gladly correct them, so please do not start this process from a position of hostility.
