Course Description and Objectives

- In this course, we deal with the behavior of individual economic units. These units
 include consumers, workers, business firms-in fact, any individual that plays a role in
 the functioning of our economy. Microeconomics explains how and why these units
 make economic decisions. We will explore how these individual decisions affect the
 supply and demand for goods and services. Topics include consumer theory, firm
 theory (production, cost), perfect competition, monopoly, and game theory.
- By the completion of the course, you should be comfortable with the analytical tools and be able to use them to observe the world. You will gain a basic knowledge of how market forces work, how government policies can affect market outcomes, and what the limits of such policies are.
- This is a "tools" course to teach you how to think logically about economic questions and prepare you for higher-level economic courses. It is based on reasoning and not memorization, so the effective way to learn the material is by doing the exercises and problems. The text also has a mathematical appendix, which you may find of assistance.

Course Prerequisites

• It is required that students in Econ 3550 have completed Principles of Microeconomics (Econ 1100) with a grade of A or B and any one of the following calculus courses: MATH 1190, or MATH 1710, with a grade of C or better.

• Landsburg, Steven (2013). Price Theory and Applications, 9th ed. Thompson Southwestern (although the 8th edition will work just as well)

• Course materials (syllabus, lecture notes, problem sets, quizzes, and practice exams) are available on the Canvas. You should print and bring the lecture notes to class.

Course Requirements

This course takes place 100% online. Every Monday, I will be posting several video lectures for you to watch. Each video lasts around 10-30 mins. You are required to watch videos of the week and finish quizzes as soon as possible.

At the end of each video, there will be a 5 mins quiz for you to take. Those quizzes questions are closely related to the video, and It is recommended that you take these quizzes right away after watching the lecture video. You can type in your solution of quizzes directly on the canvas. Each quiz is due on **Fridays**.

Almost every week, we will also have a problem set. Problem set usually requires you to draw figures, so you can write your solution on paper, take a photo of it, and submit it as an attachment on canvas. Each problem set is due next **Mondays**.

Before watching the lectures, you should read the related material in the textbook. Unless you are specifically told otherwise, appendix material is not covered.

Three exams will be given during the semester: two midterm exams and a comprehensive final exam. The exam dates and material covered on each exam are as follows:

- Midterm I: Monday, Feb.8th, 6:00pm-7:30pm (Ch 1,3,4)
- Midterm II: Monday, March 15th, 6:00pm-7:30pm (Ch 5-7)
- Final Exam: Monday, April 26th, 6:00pm-8:00pm (Ch 1,3-8,10-12)

All exams are taken on ZOOM, **meaning you must join a ZOOM meeting with the camera on**. All exams are open-book and open-notes. However, the use of Internet resources or other people (including classmates) is prohibited.

Here is the list of graded items and their contribution to your final grade. The final grade will be based on a weighted average of the percentage grades on each assignment.

Grading

There is no way to perfectly calibrate an exam so that students with A performances will score between 90 and 100 point, students with B performances score between 80 and 90 points, etc. Each mid-term exam and the final exam will be curved as needed for the performances to match the awarded grades (see below to check my criteria).

- A: 90-100%. The student demonstrates knowledge of the economic models and the intuition behind them and they also demonstrate an ability to apply the models to novel situations.
- B: 75-89%. The student demonstrates knowledge of the economic models and the intuition behind them, but has trouble applying the models to novel situations.
- C: 60-75%. The student demonstrates knowledge of the economics models, but has trouble explaining the intuition behind them and cannot apply the models to novel situations.
- F: < 60%. The student demonstrates little understanding of the course content.

Course Policies

Grade Appeals

If you think that an exam has been incorrectly graded, submit a written explanation of the problem no later than 1 week after the exams have been returned. This deadline applies regardless of whether you are present in class at the time the exams are returned. I will respond to you in writing as soon as possible. If there is still a disagreement, schedule a Zoom appointment so that we may further discuss the problem.

Late work or Make-up Exams

No late submission or make-up exams will be given unless you notify me of the situation as soon as possible and can provide documented evidence of a valid excuse. The instructor is the judge of what constitutes a valid excuse.

Withdrawals

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following: (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
