Overview

This course exposes students to the fundamentals of real estate finance. The primary objective is to examine real estate capital markets, both debt and equity. We will begin by looking at the primary residential mortgage market and the mathematics and finance of residential mortgage cash flows and pricing, understanding the pro and cons of various mortgage products. We will then move into commercial real estate market. The tools and concepts are similar to residential markets, we will focus on the unique characteristics of commercial market.

Text Book and Calculator:

Real Estate Finance & Investments, by <u>William B. Brueggeman Jeffrey Fisher</u>, 16th Edition. My lectures will follow the book loosely in most sessions and I will have supplement materials during some sessions. You will also need a **calculator**. I strongly recommend a financial calculator. I will use Texas Instruments' BA II Plus during class.

This course will require considerable study outside of class. The course will be structured as a combination of lectures, discussion and accompanied by related reading assignments and problem sets. The best way to prepare for exams is to work the assigned problems. It is very important that you keep up with the assigned work so that you will not be overwhelmed at exam time.

These quizzes will be on the material that we just covered. Each quiz will take about 15 minutes. Students who miss a quiz will receive a zero on the quiz. No make-up quizzes. Quiz is administered through canvas at the beginning of class.

We will have 2 guest speakers during the semester after each midterm. In lieu of homework for that week, you are required to write a report on the guest presentation. Details will follow. Attendance is required for both guest speakers.

Project

You will have one group project. Each group should have 3-4 students. You need to hand in the project report by the due date and have a 10 to 15 minutes class presentation. I will discuss in detail about the project around week 9 when we cover the relevant materials.

Exams

There will be 2 midterms and a final exam. Midterm Exams will cover the new material. Final exam is cumulative. No make-up exams. You may have one page cheat sheet to all the exams. All the exams are for two hours.
