

The following agreement governs the purchase and use of your ticket(s) ("Ticket(s)") to Call of Duty World League® 2019 ("Call of Duty World League"). In purchasing this Ticket and in consideration for being admitted to the Call of Duty World League, you agree:

1. to comply with the Call of Duty World League Attendee Rules that are available for your review at <https://Call of Duty World League.com/en-us/event-info/attendees/rules>;
2. to assume all risk of personal injury and all other hazards related to Call of Duty World League, whether occurring prior to, during or after Call of Duty World League, and agree that Activision Blizzard, Inc., and the venue as well as each of their parents, affiliates, licensees, officers, directors, employees sponsors, exhibitors and contractors are expressly released by holder from any claims arising from or related to such causes or otherwise occurring at or in connection with Call of Duty World League;
3. to consent to and authorize Activision Blizzard, Inc., and its affiliates and licensees, which include but are not limited to all sponsors, exhibitors and contractors, to photograph or otherwise record your likeness and/or voice and to use same worldwide, for any purpose whatsoever, in any manner or media now know or hereafter devised, in perpetuity; all such photographs and sound recordings to be the sole property of Activision Blizzard, Inc., and you hereby release Activision Blizzard, Inc., and its affiliates and licensees, which include but are not limited to all sponsors, exhibitors and contractors, from any and all claims relating to any use of your appearance and/or name as contemplated in this Ticket Agreement without further authorization or compensation;
4. that the Ticket is a revocable license which may be withdrawn and admission refused anytime upon refunding the printed purchase price. Tickets to Call of Duty World League, once purchased, cannot be refunded by the purchaser or exchanged;
5. that the Call of Duty World League is a strictly enforced smoke free environment. Coolers and large containers of any kind are not allowed into the venue, and are subject to confiscation by venue staff or Call of Duty World League personnel. Championship events will have a separate set of prohibited items designated by the venue on their website.
6. that the maximum capacity of each venue is set by fire department regulations and is strictly enforced by the venue. As a result, access to the venue that occur during Call of Duty World League will be limited to the maximum capacity of the particular hall, which will be determined by the Venue in its sole discretion;
7. that Tickets obtained from sources other than Call of Duty World League, may be lost, stolen or counterfeit and may not be honored; Tickets cannot be replaced if lost, stolen or destroyed; and the license granted by the Ticket will automatically terminate if any term is breached, and that the Ticket may not be offered for sale in any manner which would violate any law or regulation;
8. not to record or transmit, or aid in recording or transmitting, any description, account, picture, or reproduction of Call of Duty World League without first obtaining the express, written permission of Activision Blizzard, Inc.;
9. that Activision Blizzard, Inc., reserves the right, without refund of any portion of the Ticket purchase price, to refuse admission or remove from Call of Duty World League

any person whose conduct is deemed by Activision Blizzard, Inc., to be disorderly, or unbecoming, or who uses vulgar or abusive language, or who engages in harassment of any kind;

10. that certain items may not be brought into the Venue, including without limitation, alcohol, drugs, controlled substances, cameras, recording devices, bundles and containers, and that you shall consent to a reasonable search for alcohol, drugs, weapons, explosives, or other prohibited items on entry to Call of Duty World League and release Activision Blizzard, Inc., and the venue as well as each of their parents, affiliates, licensees, officers, directors, employees sponsors, exhibitors and contractors, from any claims that may arise due to such a search. If you elect not to consent to such searches, you may be denied entry, or removed from, Call of Duty World League without refund or other compensation; and
11. that due to certain content that will be on display at Call of Duty World League, minors under the age of 16 must be accompanied by a parent, guardian, or responsible adult (18 years or older) at the event. Additionally, minors under the age of 12 are not allowed into the Call of Duty World League event, and strollers are not permitted on the Call of Duty World League floor.
