

GB 15 Year Anniversary Sweepstakes

OFFICIAL RULES:

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID IN PUERTO RICO AND OTHER U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED.

1. SWEEPSTAKES TERM AND DEADLINES: The GB 15 Year Anniversary Sweepstakes (the “Sweepstakes”) begins Monday, October 15, 2018 at 12:00am Pacific Daylight Time (“PDT”) and ends Sunday October 21, 2018 at 11:59pm PDT (“Sweepstakes Period”). Fifteen (15) winners will be selected in a random drawing held each day from among all eligible entries received during the Sweepstakes Period (Fifteen (15) total winners). All entries received after the end of the Sweepstakes Period will be ineligible for the chance to win a prize.

2. ELIGIBILITY: The Sweepstakes is open and offered only to legal residents of the 50 United States and the District of Columbia (excluding Puerto Rico and other U.S. territories and possessions), 18 years of age or older (except residents of Alabama and Nebraska, who must be 19 years of age or older and residents of Mississippi, who must be 21 years of age or older) at the time of entry. Sweepstakes is void in Puerto Rico and other U.S. territories and possessions and where prohibited or restricted by law. Participants must be following @GameBattles from their own personal Twitter account and must have “United States” selected from the dropdown menu in the Settings area of their Twitter account. Employees, officers and directors of Major League Gaming Corp. (“Sponsor”) and each of their respective parents, affiliated companies and subsidiary companies, and their advertising, promotion, or production agencies, prize providers, Web masters and Web suppliers, and each of their respective officers, directors, employees, representatives and agents (collectively, with Sponsor, the “Sweepstakes Entities”), and their IRS dependents, immediate families (spouse and parent, child, sibling and their respective spouses, regardless of where they reside) and/or members of their households, whether or not related, are ineligible to participate in this Sweepstakes. HOW TO ENTER: To enter this Sweepstakes, entrants must first follow the official GameBattles Twitter feed by going to the GameBattles Twitter page located at <https://twitter.com/GameBattles> and clicking the “Follow” button while logged into their Twitter account; and the official MLG Twitter feed by going to the MLG Twitter page located at <https://twitter.com/MLG> and clicking the “Follow” button while logged into their Twitter account. During the Sweepstakes Period, @GameBattles will tweet a call-to-action message which the entrant must “like” and re-tweet by Sunday October 21, 2018 at 11:59pm PDT to be eligible to win a prize. Limit of one (1) entry per person/per Twitter account/email address/household, regardless of method of entry. Proof of submission is not proof of receipt. If you post updates to or receive updates from Twitter via SMS from your wireless device, your wireless services provider may charge you for each text message you send and receive. Please

consult your wireless services provider for more information. Sponsor is not responsible for any charges wireless services provider may charge entrant. Any attempt at e-mail or other method of entry is void. Any attempt by any person to obtain more than the stated number of Entries by using multiple/different Twitter accounts, or any other methods including, without limitation, script, macro or any automated or other means which subverts the entry process, will void all of that person's entries and that person will be disqualified. Re-tweets must comply with Twitter terms of use and shall not contain content that is unlawful or inconsistent with Sponsor, Gamebattles or its brand image. Submissions may not promote or portray any activities that may appear unsafe or dangerous to yourself or other persons or property. DO NOT engage in any activity that is potentially dangerous or beyond your ability. Entries may not contain any content that is lewd, obscene, sexually explicit, pornographic, disparaging, defamatory, libelous, or otherwise contains inappropriate or objectionable content as determined by Sponsor in its sole discretion. Sponsor may disqualify any such Entry at its sole discretion.

4. DRAWING: One (1) random drawing will be held after the conclusion of the Sweepstakes Period. Fifteen (15) winners will be randomly drawn from the eligible entries received during the Sweepstakes Period. The random drawings will be conducted by Sponsor, whose decisions are final and binding on all matters relating to the Sweepstakes. Odds of winning depend on the number of eligible Entries received.

5. WINNER NOTIFICATION: Within thirty (30) business days of the conclusion of the Sweepstakes Period, Sponsor shall endeavor to notify potential winners (each a "Winner") via Twitter Direct Message ("DM") to obtain email, mailing address and phone number. Winner may be subject to verification of the entrant's eligibility and compliance with these Official Rules. Winner notification not acknowledged by winner within twenty-four (24) hours after outreach from Sponsor may be forfeited at Sponsor's discretion and awarded to an alternate winner selected by Sponsor. Any prizes not claimed by alternates within twenty-four (24) hours after outreach from Sponsor shall be considered forfeited and shall be discarded at the Sponsor's sole discretion.

CONDITIONS OF PARTICIPATION: Entrants agree (a) that the Sweepstakes Entities and Twitter will have no liability whatsoever for, and shall be held harmless against any liability for any injuries, losses or damages of any kind to persons, including death, or property damage resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of the prize, or participation in this Sweepstakes or any Sweepstakes related activity, or for any printing, production, typographical, human or other error in the printing, offering or announcement of any prize; and (b) except where legally prohibited, each winner grants (and agrees to confirm such grant in writing) permission for Sponsor and those acting under its authority to use winner's name, city and state of residence, photograph, voice and/or likeness, for advertising, trade and/or publicity purposes without additional compensation in any and all media now known or hereafter discovered, worldwide and on the World Wide Web, in perpetuity, in any manner, without notice, review or approval. By participating in Sweepstakes, entrants hereby agree that Major League Gaming Corp. may collect and use their personal information in compliance with its Privacy Policy and acknowledge that they have read and accepted the Major League Gaming Corp.'s Privacy Policy.

11. ARBITRATION: Any dispute whatsoever relating to the Sweepstakes which is not resolved within the thirty (30) day period commencing upon receipt of written notice by either party from the other party, shall be settled by binding and final arbitration before a single arbitrator. The demand for arbitration shall be made within a reasonable time after a claim, dispute, breach or other matter in question has arisen, and in no event shall it be made after two years from when the aggrieved party knew or should have known of the claim, dispute or breach. The arbitration shall be conducted pursuant to the Commercial Arbitration Rules of the American Arbitration Association (the "AAA Rules"). Arbitration shall be by a single arbitrator experienced in the matters at issue selected pursuant to the AAA Rules. The arbitration shall be held in such place in the metropolitan area of Los Angeles, California, as may be specified by

the arbitrator (or such other place upon which the parties and the arbitrator may agree), and shall be conducted pursuant to the AAA Rules (regardless of any choice of law provision in this Agreement) to the extent not otherwise inconsistent with this Agreement. The parties shall not be entitled to discovery other than the exchange of relevant documents and one deposition not to exceed eight hours, except as otherwise allowed by the arbitrator or the AAA rules.

However, the parties shall also be entitled to depose any expert that will be presented to testify at the arbitration hearing. The decision of the arbitrator shall be final and binding as to any matters submitted to arbitration and shall be in lieu of any other action or proceeding of any nature whatsoever; and, if necessary, any judgment upon the arbitrator's decision may be entered in any court of record having jurisdiction over the subject matter or over the party against whom the judgment is being enforced. The arbitrator shall issue a reasoned opinion to support his or her final award, and shall have no power to issue any ruling that either is not consistent with, or is contrary to, California law. The arbitrator also shall have no power to award exemplary, special or punitive damages, and shall further have no power to award incidental or consequential damages or damages for lost profits. The reasonable attorneys' fees and costs of the prevailing party (as determined by the arbitrator) shall be reimbursed by the other party. Except as required by law, the parties agree to keep confidential the existence and details of any dispute subject to this provision, including the results of arbitration. The foregoing shall not be deemed to prohibit a party from disclosing relevant information to its legal, financial and other advisors in connection with any such dispute as long as such advisors agree to maintain the confidentiality thereof pursuant to this provision.

12. CHOICE OF LAW: Any and all legal actions or claims arising in connection with this Sweepstakes must be brought in a court of competent jurisdiction in New York, NY. Except where prohibited, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, and in no event will entrant be permitted to obtain attorneys' fees or other legal costs; (3) no punitive, incidental, special, consequential or other damages, including without limitation lost profits may be awarded (collectively, "Special Damages"); and (4) entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased. New York law, without reference to New York choice of law rules, governs the Sweepstakes and all aspects related thereto.
