

The following agreement governs the purchase and use of your ticket(s) ("Ticket(s)") to Major League Gaming 2019 ("Major League Gaming"). In purchasing this Ticket and in consideration for being admitted to the Major League Gaming events, you agree:

1. to comply with the Major League Gaming Attendee Rules that are available for your review at <https://s3.amazonaws.com/mlg-gamebattles-production/assets/arenacp/files/1551472534/MLG%20EVENT%20RULES%20AND%20DETAILS.pdf>;
2. to assume all risk of personal injury and all other hazards related to Major League Gaming, whether occurring prior to, during or after Major League Gaming, and agree that Activision Blizzard, Inc., and the venue as well as each of their parents, affiliates, licensees, officers, directors, employees, sponsors, exhibitors and contractors are expressly released by holder from any claims arising from or related to such causes or otherwise occurring at or in connection with Major League Gaming;
3. to consent to and authorize Activision Blizzard, Inc., and its affiliates and licensees, which include but are not limited to all sponsors, exhibitors and contractors, to photograph or otherwise record your likeness and/or voice and to use same worldwide, for any purpose whatsoever, in any manner or media now known or hereafter devised, in perpetuity; all such photographs and sound recordings to be the sole property of Activision Blizzard, Inc., and you hereby release Activision Blizzard, Inc., and its affiliates and licensees, which include but are not limited to all sponsors, exhibitors and contractors, from any and all claims relating to any use of your appearance and/or name as contemplated in this Ticket Agreement without further authorization or compensation;
4. that the Ticket is a revocable license which may be withdrawn and admission refused anytime upon refunding the printed purchase price. Tickets to Major League Gaming, once purchased, cannot be refunded by the purchaser or exchanged;
5. that the Major League Gaming is a strictly enforced smoke free environment. Coolers and large containers of any kind are not allowed into the venue, and are subject to confiscation by venue staff or Major League Gaming personnel. Championship events will have a separate set of prohibited items designated by the venue on their website.
6. that the maximum capacity of each venue is set by fire department regulations and is strictly enforced by the venue. As a result, access to the venue that occur during Major League Gaming will be limited to the maximum capacity of the particular hall, which will be determined by the Venue in its sole discretion;
7. that Tickets obtained from sources other than Major League Gaming, may be lost, stolen or counterfeit and may not be honored; Tickets cannot be replaced if lost, stolen or destroyed; and the license granted by the Ticket will automatically terminate if any term is breached, and that the Ticket may not be offered for sale in any manner which would violate any law or regulation;
8. not to record or transmit, or aid in recording or transmitting, any description, account, picture, or reproduction of Major League Gaming without first obtaining the express, written permission of Activision Blizzard, Inc.;

9. that Activision Blizzard, Inc., reserves the right, without refund of any portion of the Ticket purchase price, to refuse admission or remove from Major League Gaming any person whose conduct is deemed by Activision Blizzard, Inc., to be disorderly, or unbecoming, or who uses vulgar or abusive language, or who engages in harassment of any kind;
10. that certain items may not be brought into the Venue, including without limitation, alcohol, drugs, controlled substances, cameras, recording devices, bundles and containers, and that you shall consent to a reasonable search for alcohol, drugs, weapons, explosives, or other prohibited items on entry to Major League Gaming and release Activision Blizzard, Inc., and the venue as well as each of their parents, affiliates, licensees, officers, directors, employees sponsors, exhibitors and contractors, from any claims that may arise due to such a search. If you elect not to consent to such searches, you may be denied entry, or removed from, Major League Gaming without refund or other compensation; and
11. that spectators who are 13 to 15 years old must be accompanied by a parent or legal guardian and present a signed parental consent form. Spectators who are 16 and 17 years old must present a signed parental consent form. Any spectator under the age of 13 is not permitted in the venue.
