



## THE BARBARA W. SMITH FAITH IN ACTION SCHOLARSHIP

### Undergraduate Scholarship Application

#### **Eligibility Criteria**

- Applicants must have been a member of Covenant United UCC for at least one year
- Applicants must attend Sunday School at CUCC
- Applicants must provide evidence of excellence in a subject area, talent, or skill
- Applicants must be a senior in high school entering a post-secondary or vocational program
- Applicants must have a minimum grade point average (GPA) of 2.75 on a 4.0 scale or be in the top one-third of their class
- Applicants must have applied and gained acceptance into a full-time post-secondary or certificate program
- Applicants must submit 3 letters of recommendation from a current/previous employer, teachers, and/or others in a supervisory position or those who know them well

#### **Application Requirements**

*Note: The submission of any materials with an application other than those requested will be discarded. Please only include what has been requested and do NOT put materials into binders, slipcovers or report covers. A staple, paper clip, or binder clip will suffice.*

- TYPED application (a word-processed document may be used in place of the application, only if presented exactly in the order of the application). Answer every space. Mark "N/A" if it does not apply to you. A blank space will automatically be considered an incomplete application.
- Transcript from each high school attended (unofficial transcripts will be accepted; report cards will not)
- Proof of community service or relevant work experience stipulating number of hours worked
- Proof of attendance in Sunday School, signature required
- Letter of acceptance into an accredited college, university, or vocational program
- 3 letters of recommendation on letterhead from a current or previous employer, teacher, etc.

### **The Faith in Action Scholarship Committee Will Score the Following:**

- Presentation of application (neatness, spelling, punctuation, etc.)
- GPA
- Related community, performance, or work experience
- Strength of letters of recommendation
- Essays
- Interview

**Prompt 3: Briefly describe a situation in which you felt that you or others were treated unfairly or were not given an opportunity you felt you deserved. Why do you think this happened? How did you respond? Did the situation improve because of your response?**

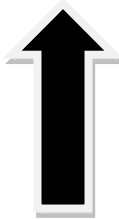
