CONDITIONS OF PARTICIPATION

Rabies tag & license required. All dogs must have a collar and a leash must be on hand by owner. Limit one dog per handler, NO aggressive dogs allowed (any dog exhibiting aggressive behavior will be required to leave with no refund). Every owner takes full responsibility for his or her dog at all times. Every owner must provide proof of vaccinations and license within 24 hours upon request.

WAIVER AND ACCEPTANCE OF RESPONSIBILITY

I, the above-mentioned Owner ("Owner"), hereby acknowledge that my voluntary participation in the "PigDog Puppa Palooza" event (the "Event") at Mariner's Pier located at 3501 Boardwalk Wildwood, New Jersey 08260 the (the "Park") on September 10, 2022 may result in personal injury to me and/or my above-mentioned dog ("Dog"). BY PARTICIPATING IN, ATTENDING AND/OR OBSERVING THE EVENT, I ACKNOWLEDGE AND ASSUME ALL RISKS AND DANGER TO ME THAT ARE INCIDENTAL TO OR IN ANY WAY ARISE FROM THE EVENT, INCLUDING, WITHOUT LIMITATION, ALL RISKS AND DANGER INHERENT IN A CANINE-ORIENTED EVENT (E.G., DOG BITES, FIGHTS OR ALTERCATIONS, FALLS, CONTACT WITH SPECTATORS AT THE EVENT). I FURTHER AGREE TO ASSUME LIABILITY FOR ANY AND ALL MEDICAL COSTS INCURRED AS A RESULT OF MY PARTICIPATION IN THE EVENT THAT ARE NOT COVERED BY MY INSURANCE, INCLUDING BUT NOT LIMITED TO COSTS OF MEDICAL CARE AND TREATMENT, AMBULANCE SERVICES, HOSPITAL STAYS, AND PHYSICIAN TREATMENT.

I accept full responsibility for any and all actions of the Dog and agree that the Dog will be in my care and control during the Event. I hereby represent and confirm that the Dog is in good health and has a current rabies vaccination and that the Dog is not the subject of a quarantine order, a pending adjudication or administrative hearing, and has never been declared a dangerous, potentially dangerous or vicious or potentially vicious dog. I agree to be bound by the terms of the rules and regulations established by Morey's Piers for both the Park and the Event, and I will abide by all applicable governmental laws, ordinances, orders, directions, rules and regulations, as well as all rules and regulations that are adopted for this Event by the Morey's Piers or any of its affiliates. I acknowledge that Morey's Piers reserves the right to exclude or eject any and all unruly, rowdy or disruptive Owners and/or Dogs from the Event and/or the Park without liability and that I shall be fully responsible for any damages or expenses, direct or indirect, incurred as a result of my or my Dog's disruptive behavior and/or ejection. I further agree that any Park official may authorize necessary treatment for me and/or the Dog in the event of injury.

I hereby agree to defend and indemnify Morey's Piers and all of its affiliated entities and its and their employees and agents against any and all actions, causes of action, claims, suits, demands (or other legal actions), losses, damages, costs and/or expenses (including, without limitation, reasonable attorney's fees and disbursements) for personal injury, property damage or any other injury or loss of any kind arising out of, in connection with, or resulting from my and/or my Dog's participation in and/or attendance at the Event, regardless of who causes the injury or loss sustained and regardless of whether based on fault or negligence or not.

I further agree that by signing below, and in consideration of my participation in the Event, I authorize Morey's Piers, and other affiliated entities to depict in perpetuity my and my Dog's likeness, images, name, words, voice, and biographical information ("Images") in photographic or other works appearing in any and all media for purposes of promoting, advertising, or marketing current or future events related to Morey's Piers, and I agree that such Images may be used by them for that purpose without compensation.

For 1-Mile Beach Walk Participants

I am aware that during my participation and attendance in the Morey's PigDog Puppa Palooza and related activities, Morey's Piers and its sponsors will be providing various facilities and arrangements, and that certain risks and dangers may occur, including, but not limited to hazards inherent in the event; negligence or other careless acts and omissions by Morey's Piers, other participants, spectators and the sponsors; and hazardous or dangerous conditions of facilities and grounds.

In consideration of the acceptance of my entry, and the right to participate, I do hereby assume all of the above risks, waive and release any and all claims or causes of action of any kind and nature which I may now or hereafter have against Morey's Piers and/or their sponsors. The terms hereof shall serve as a release, waiver and assumption of risk for my heirs, executors and administrators, and for all members of my family, including any minors accompanying me.

Consent to Medical Treatment: Additionally, in consideration and acceptance of my entry by Morey's Piers and the right to participate in related activities, I consent to receive any and all emergency medical treatment as may be deemed appropriate under the existing circumstances as then determined by the tournament organizers.

Parent/Guardian of Participant - required if participant is under 18. I consent and agree to the above on my child's behalf, to release, waive and assume the risks of any claims or causes of action which my child or I may now or hereafter have against each of the organizations and individuals listed above, and I consent to allow my child to receive emergency medical treatment as deemed necessary and appropriate.
