#### **WELCOME**

Welcome to Morey's Piers and Beachfront Water Parks! At Morey's Piers, we work hard to offer all of our Guests a safe and enjoyable environment. This guide describes the accommodations Morey's Piers offers to Guests with disabilities and provides a detailed description of rider restrictions and access options for each of our attractions.

Please note that all information is subject to change. Please speak to an Associate in one of our Guest Services locations for the most up-to-date accessibility information, or to answer any questions you may have about our accommodations.

Morey's Piers reserves the right to make the final determination regarding eligibility of a Guest to ride a particular attraction based on the Guest's size, weight, height, and other limitations. Information in this guide is subject to change.

All Guest Services locations are fully accessible and are located in the following areas:

Mariner's Pier – Under the Sea Serpent, located behind the Tea Cups, in the center of the pier.

Surfside Pier – Toward the rear of the pier, on the south side, behind AtmosFEAR.

**Adventure Pier** – Toward the rear of the pier, located directly under the Great White loading station.

Raging Waters Water Park – In the center of the water park, past the main locker area.

Ocean Oasis Water Park and Beach Club — Inside the water park at the bottom of the main entrance steps, next to the Puddle Pool.

# **ACCESSIBLE PARKING / BOARDWALK ACCESS**

Morey's Piers offers accessible parking spaces in our main lots, located on the corner of Schellenger and Atlantic Avenue and the corner of Poplar and Ocean Avenue. Parking is available on a first-come-first-served basis.

In addition, various other independently owned and operated parking lots in Wildwood are available and offer different levels of service and accessibility. Guests should inquire at the parking lot entrance for accessibility options.

Most street ends offer ramped access to the Wildwood Boardwalk, which is managed by both the City of Wildwood and North Wildwood. Additionally, most street ends allow for passenger drop-off and pick-up. #### **SERVICE ANIMALS**

Service animals are defined as dogs or miniature horses that are individually trained to do work or perform tasks for people with disabilities.

Service animals are permitted in most locations at Morey's Piers. Service animals must be harnessed, leashed, or tethered, unless these devices interfere with the service animal's work or the individual's disability prevents using these devices. If a service animal is out of control and the handler does not take effective action to control it, the handler may be asked to remove the animal from the premises.

# **SERVICE ANIMALS (Continued)**

Associates are not permitted to handle service animals. Service animals are welcome in all of our restaurant and merchandise locations, attraction queues, water parks, and most other locations. Due to safety considerations and the dynamic nature of our rides and attractions, service animals are not permitted on most rides. See RIDE SPECIFIC DETAILS section for more information on which attractions permit service animals. In both water parks, service animals are permitted on facility grounds, but are not permitted to enter the pools or water attractions.

For your convenience, there are designated "relief areas" located on each pier. Each relief area features an artificial turf surface and a plastic bag dispenser. We kindly request that you clean up after your animal using one of the plastic bags dispensed at the relief station.

Relief areas are at the following locations:

**Mariner's Pier** – Behind the Musik Express, accessed through the path between Rollie's Coaster and the Musik Express operator booth.

Surfside Pier – Behind the Kang'A Bounce, located on the north side of the pier.

# **WHEELCHAIRS / ECVs**

For your convenience, most of our facilities are wheelchair-accessible. There are specific boarding requirements and accommodations at most attractions for Guests using wheelchairs, all of which are described in the RIDE SPECIFIC DETAILS section. Some attractions feature auxiliary access entrances. Guests using the access entrances may be accompanied by up to 3 other Guests.

In most cases, if you are capable of transferring to the ride vehicle's seating (either by yourself, or with the help of another person in your party), you may transfer. Some attractions are capable of allowing Guests to remain in a standard wheelchair for all or part of the attraction experience. Morey's Piers associates are not permitted to lift or transfer Guests from wheelchairs or ECVs.

Please note that most of our attractions have posted physical requirements. All Guests, including Guests using wheelchairs, must meet the posted physical requirements of all attractions they wish to ride. See RIDE SPECIFIC DETAILS section for wheelchair/ECV accessibility and boarding procedures for each attraction.

#### **FIRST AID**

First Aid facilities are fully accessible by wheelchair and are in the following locations:

Mariner's Pier – Between the Super Scooters and the Mini Scooters (bumper cars).

**Surfside Pier** – Toward the rear of the pier, behind Guest Services.

**Adventure Pier** – Inside of Guest Services, toward the rear of the pier, under the Great White loading station.

Raging Waters Water Park – Adjacent to the Fountain Pool.

Ocean Oasis Water Park and Beach Club – In the rear of the park, next to the Activity Pool.

Morey's Piers First Aid facilities do not dispense medications. However, some over-the-counter medications are available for purchase at the retail locations on each pier.

#### **RESTROOMS**

Each of our facilities offers accessible restrooms designed for use by Guests using wheelchairs or ECVs. Accessible restrooms are in the following locations:

Mariner's Pier – Next to Guest Services on pier level (under the Sea Serpent Roller Coaster, located in the center of the pier).

**Surfside Pier** – Toward the rear of the pier, behind the Great Nor'easter station.

**Adventure Pier** – Toward the rear of the pier, located directly next to Guest Services, under the Great White loading station.

**Raging Waters Water Park** – At the front of the park, near the Activity Pool and the Sky Pond Splash Pool.

Ocean Oasis Water Park and Beach Club – In the center of the park, next to the locker sales area.

For Guests requiring the assistance of a companion, "companion/family" restrooms are in the following locations:

Mariner's Pier – Next to Guest Services on pier level (under the Sea Serpent Roller Coaster, located in the center of the pier).

Ocean Oasis Water Park and Beach Club - Near the Waterlilies Cabana Area.

#### **OXYGEN TANKS**

Due to ride dynamics and other safety considerations, oxygen tanks are not permitted on most rides. Guests may use oxygen tanks while walking around our facilities.

#### **RETAIL LOCATIONS**

Our main retail locations, Kong & Co. on Surfside Pier and The Morey Store on Mariner's Pier are accessible to Guests using wheelchairs or ECVs. Please speak to a retail Associate for any assistance with retail items, including reaching merchandise or reading price tags.

#### **RESTAURANTS AND CONCESSIONS**

Most concession areas throughout Morey's Piers and Beachfront Water Parks are accessible to Guests using wheelchairs and ECVs. If you encounter any difficulties, please speak to an Associate for assistance.

All full service restaurants are accessible to Guests using wheelchairs and ECVs. These include Founders Grub & Pub on Mariner's Pier, Joe's Fish Co. on Surfside Pier, and Stubborn Brothers Grill at Ocean Oasis Water Park. Guests with vision impairments may ask any Associate for assistance with obtaining information on menu items. Additionally, any Associate will be happy to assist with restaurant orders and bringing orders to the tables.

PLEASE BE ADVISED THAT ALL CURLEY'S FRIES LOCATIONS USE PEANUT OIL. THERE MAY ALSO BE A RISK OF CROSS CONTAMINATION TO NEARBY FOOD SERVICE AREAS.

#### **MIDWAY GAMES**

Most games are fully accessible by wheelchair. The water race game located at the front of Adventure Pier can be configured to allow wheelchair access. Speak to a Games Associate for assistance.

#### RIDES AND ATTRACTIONS

#### **MAGNETIC FIELDS AND METAL DETECTORS**

Magnets are present in the mechanical components of most of our attractions. Additionally, most of our ride area gates are locked with magnetic latches. Some rides may use magnets of greater power and intensity than others. Those rides include AtmosFEAR, the Great Nor'Easter, Runaway Tram, Rollie's Coaster, the Sea Serpent, and the Spring Shot. Guests using medical devices that are sensitive to magnetic fields should consult with their physician and the medical device's manufacturer before deciding to ride any attraction.

The Great Nor'Easter uses both handheld and walk-through metal detectors to assist in the screening of riders for loose articles. Please see an associate at the entrance of the ride for assistance if exposure to these devices cause concern.

#### **NOISE REDUCING HEADPHONES**

Due to the high dynamic forces of some attractions, Guests wearing large noise reducing headphones, that cover the entire ear, may not be permitted to ride while wearing the device. Those rides include the Zoom Phloom, "it", RipTide, as well as all Roller Coasters and Extreme Rides.

#### HEARING AIDS AND COCHLEAR IMPLANT SOUND PROCESSORS

Hearing Aids and Cochlear Implants, while permitted on all rides and attractions, should be brought on rides at the discretion of the rider or rider's guardian. Morey's Piers cannot be held responsible for lost or damaged items due to the dynamic forces of its rides.

#### **PROSTHETICS AND CASTS**

Guests who are recovering from recent injuries should not ride most rides. Guests with casts or braces that interfere with the proper function of a ride's restraint system will not be permitted to ride. Please see the RIDE SPECIFIC DETAILS section for information on whether prosthetics or casts are permitted on specific attractions.

#### **GUESTS OF UNIQUE BODY PROPORTIONS**

The restraint systems on our attractions are engineered to accommodate Guests of average stature and proportion. All restraint systems, including lap bars, shoulder harnesses, and seatbelts must be positioned and fastened properly for a Guest to ride. Guests and team members will not force a restraint system to secure it. Due to the design of certain restraint systems, some Guests may be unable to ride some attractions. This may apply, but not be limited, to Guests who exceed 6'2" in height, and/or exceed 225 lbs.

#### **NEW JERSEY STATE LAW**

Each attraction is subject to the laws and regulations of the State of New Jersey. State law requirements, as well as manufacturer and park requirements, are posted at the entrance to each attraction. These laws, regulations, and rules will be strictly enforced. Violation of verbal or posted written warnings, or engaging in behavior that is reckless and may cause or contribute to the injury of yourself or another rider may expose you to criminal prosecution under N.J.S.A. 5:3-36.1. Violators of these regulations are subject to fines of up to \$1,000, and up to 6 months imprisonment.

#### WATER PARK SPECIFIC DETAILS

Always observe attractions before participating. Only you know your physical conditions or limitations. All guests have a duty to exercise good judgment and act in a responsible manner while participating on a ride or attraction and to obey all verbal and written warnings and instructions. In order to ride, Guests must possess the physical and cognitive abilities to hold themselves in the proper ride position throughout the course of the ride.

Only you know your swimming ability, and that of your children and anyone you are supervising. We strongly recommend all Guests under 48" or who are weak or non-swimmers wear a U.S. Coast Guard approved lifejacket. We offer complimentary lifejackets for daily use throughout the water parks. We suggest that supervising companions keep Guests requiring assistance within arm's reach and under close supervision at all times.

#### **GENERAL WATER PARK SAFETY**

- Each attraction has specific requirements that are posted at each attraction. In general, restrictions are based on height, weight, medical conditions, and appropriate behavior. In order to participate on all slide attractions, Guests must have independent head and neck control, full body control, and the ability to brace and balance.
- Water shoes are permitted to be worn throughout the water parks, on walkways, in restrooms, in the Lazy Rivers, Activity Pools, children's areas, etc. However, we do not permit shoes to be worn on any of the water slides for safety reasons. Our goal is to operate a safe park and for various safety reasons, we have prohibited water shoes from use while riding the slides.
- Guests must be able to climb the stairs of the slide tower with or without assistance.
- In order to ride, Guests must possess the physical and cognitive abilities to hold themselves in the proper ride position throughout the course of the ride.
- For Guests participating on mat slides, each rider should have the physical and cognitive abilities to remain in a prone position, headfirst, while controlling their limbs throughout the course of the ride.

#### **RAGING WATERS**

#### **Adventure River**

Attraction entrance is accessible via ramped access into pool area.

#### **Shipwreck Shoals**

Attraction pool is accessible via a zero depth entry.

#### **Camp Kidtastrophe**

Attraction pool is accessible via a zero depth entry.

#### **Activity Pool**

• Attraction is accessible via a self-service pool lift. Please see a staff member if you need assistance.

#### **Fountain Pool**

Attraction is accessible via transfer grab bars.

#### **OCEAN OASIS**

#### Bonzai Beach

Attraction pool is accessible via a zero depth entry.

#### **Lazy River**

• Attraction is accessible via a self-service pool lift. Please see a staff member if you need assistance.

#### **Puddle Pool**

• Attraction is accessible via a self-service pool lift. Please see a staff member if you need assistance.

#### **Activity Pool**

• Attraction is accessible via a self-service pool lift. Please see a staff member if you need assistance.

#### **Cliff Dive**

• Strong swimmers only. Lifejackets are not permitted to be worn while riding this attraction.

#### **RIDE SPECIFIC DETAILS**

In addition to the safety guidelines described in this document, all Guests should exercise common sense in deciding whether to ride an attraction. If you are in doubt about whether you can safely ride an attraction given your particular physical condition, please speak to one of our team members for further information about the attraction's features. In all cases, do not board an attraction if there is any doubt that you can ride safely with your physical condition.

Morey's Piers team members are not permitted to lift or transfer Guests from wheelchairs or ECVs into ride vehicles. All Guests must be able to board a ride by themselves or with the assistance of another member of their party.

Please note that most of our attractions have posted physical requirements, including minimum height requirements. All Guests, including Guests using wheelchairs, must meet the posted physical requirements of all attractions they wish to ride. Guests who are unable to stand for height measurement should visit a Guest Services location, where they will be measured by an Admissions Associate.

#### **GENERAL RIDE SAFETY**

- Unless stated otherwise in this guide, riders must exhibit independent posture control, must be able to hold their heads upright, and must have appropriate center of gravity for bracing and maintaining a seated position during the ride.
- Unless stated otherwise in this guide, casts and braces are generally permitted on attractions if they fit
  comfortably within the ride vehicle, do not interfere with the proper operation of the ride's restraint
  mechanism, do not interfere with the rider's ability to grasp or brace as required, and do not interfere
  with the rider's ability to engage in the participatory component of certain attractions. All Guests should
  carefully consider whether participating in the attraction will exacerbate the existing injury. Due to the
  dynamic nature of some rides, casts or braces may not be permitted.
- Unless stated otherwise in this guide, securely attached prosthetics can be considered functioning limbs and extremities (hands and feet) if they provide sufficient capacity for bracing and grasping under the dynamic conditions of the ride.
- In addition to meeting the ride-specific eligibility criteria listed in this guide, riders must meet all age, height, cognitive, accompaniment, and New Jersey state law requirements. These requirements are posted at each attraction.
- Many rides will require riders to step up into an elevated ride vehicle, or transfer from a wheelchair into
  the ride seat. Please note that although ride Attendants are happy to provide limited assistance
  steadying a Guest transferring into a ride vehicle, they are not permitted to assist in lifting a rider from a
  wheelchair. Guests must be able to board a ride vehicle independently, or with the help of a party
  member.
- In most cases, ride areas are wheelchair-accessible through the exit gate. Any exceptions are listed in this guide. In all cases, never enter a ride area without the consent of a ride Attendant. Where wheelchair-access is through a ramp, ramp locations are indicated on each attraction by a blue wheelchair transfer sign.
- Always observe at least one ride cycle before boarding an attraction. Be certain that you understand
  and are comfortable with the ride action. If you do not feel comfortable with the fit of a restraint, DO
  NOT ride the attraction, and ask to speak to a member of the management team.
- Rarely, evacuations may be required in the event of a mechanical problem or power interruption. Please
  note that in the unlikely event of an evacuation, Guests may be required to walk certain distances, and
  negotiate stairs and/or narrow walkways. Guests who are not ambulatory can have a companion assist
  them, or may be required to wait in the vehicle for an extended period of time for assistance. Please
  inquire about specific procedures prior to boarding an attraction.
- This guide does not constitute medical advice. This guide describes the minimum manufacturer, regulatory, or operational restrictions for each attraction. Please speak with your physician to determine whether you are in the appropriate physical condition to ride an amusement ride.

#### **DEFINITIONS**

**Adult** - An Adult is considered to be a person who is 16 years of age or older, is able to understand rider instructions, and who meets all other criteria for riding alone.

**Supervising Companion** - A Supervising Companion is considered to be a person who is 14 years of age or older, is able to understand rider instructions, is able to assist a Guest (under the minimum height to ride alone) in complying with rider instructions, and who meets all other criteria for riding alone.

**Infant** - An infant is considered to be a child less than 12 months of age who cannot walk.

**Independent posture control** - A Guest has independent posture control if he/she has sufficient muscular control to support his/her head and neck, upper torso, and maintain proper posture during the ride without the use of a device or another person.

**Appropriate center of gravity** - Riders must have a center of gravity that does not interfere with the safe operation of the ride's restraint mechanisms.

**Upper Limb** - An upper limb is an arm with remnant to the elbow.

**Functioning Upper Limb** - A functioning upper limb is an arm with remnant to the elbow that allows the ability to grasp/brace.

**Functioning Arm** - A functioning arm is an arm with remnant to the wrist that allows the ability to grasp/brace. Unless stated otherwise in this guide, a securely attached prosthetic device is considered a functioning arm.

**Functioning Hand** - A functioning hand is a hand over which a person has control and that allows the ability to grasp/brace. Unless stated otherwise in this guide, a securely attached prosthetic device is considered a functioning hand.

**Lower Limb** - A lower limb is a leg remnant to the knee.

**Functioning Lower Limb** - A functioning lower limb is a leg remnant to the knee that allows the ability to brace.

**Functioning Leg** - A functioning leg is a leg to the ankle over which a person has control and that allows the ability to brace. Unless stated otherwise in this guide, a securely attached prosthetic device is considered a functioning leg.

**Full Leg** - A full leg is a leg to the ankle.

**Ability to grasp/brace** - Ability to grasp means the ability to support one's posture and position by maintaining a grasp on any handle or restraint bar. Ability to brace means the ability to use one's limbs or extremities to support and maintain a seated position under the forces of the ride.

#### **GLOSSARY OF SYMBOLS**



This ride may be hazardous to Guests with heart conditions or abnormal blood pressure.



This ride is prohibited for Guests who are pregnant.



This ride may be hazardous to Guests who are pregnant.



Guests must secure or remove prostheses before riding to prevent hazards or loss due to ride forces.



This ride may be hazardous to Guests with serious back or neck problems.



Guests must remove prosthetic limbs before riding to prevent hazards or loss due to ride forces.




This ride may be hazardous to Guests with other health problems that may make them more vulnerable to injury.



Service animals are permitted on this attraction. See ride operations team member for assistance.



This ride is not recommended for Guests who suffer from motion sickness.



Guests using ECVs must transfer to a conventional wheelchair.



This ride may be hazardous to Guests who are susceptible to a fear of heights.



Guests using wheelchairs must transfer to the ride vehicle.




This ride is not recommended for Guests who have medical conditions that may be aggravated by strobe lights.



This ride is not recommended for Guests wearing casts. Some casts may be prohibited.

# **Airplanes**





Physical Requirement - Riders must have at least one lower limb or be accompanied by a Supervising Companion.

Other Restrictions - Guests who are pregnant shall not ride.

# **Baby Venice**











**Height Requirement -** Guests over 52" tall are not permitted to ride.

**Physical Requirements** - Riders must exhibit independent posture control.

**Attraction Access** - Service animals are permitted on this attraction.

#### **Balloon Race**











Height Requirement - Riders must be 42" tall or accompanied by a Supervising Companion. A Supervising Companion may accompany no more than one child who is under the height requirement to ride alone.

Physical Requirements - Riders without independent posture control may ride only if accompanied by a Supervising Companion.

Attraction Access - Riders must be able to enter and exit a ride vehicle that will move while entering and exiting. Riders must ascend and descend stairs to enter and exit ride area. Service animals are permitted on this attraction.

#### Carousel













Height/Age Requirements - Riders must be 40" tall or accompanied by a Supervising Companion. Riders under 5 years of age, who meet the height requirement, must be accompanied by a Supervising Companion. Supervising Companion must stand next to horse on which the child is riding.

**Physical Requirements** - To ride a horse, riders must be able to grasp/brace with at least one functioning upper limb and brace with at least one functioning lower limb or have two functioning lower limbs to securely straddle the horse and maintain their balance. Riders who do not meet these requirements may ride in a chariot, bench, or swing. Riders without independent posture control may ride only if accompanied by a Supervising Companion.

Other Restrictions - If riding in a spinning tub, riders with hair longer than waist-length must be secured.

Attraction Access - The ride platform is elevated above ground level. Service animals are permitted on this attraction.

# **Crazy Bus**



**Height Requirement** - Riders must be 36" tall or accompanied by a Supervising Companion.

**Physical Requirements** - Riders must be able to grasp/brace with at least one functioning upper limb or have one lower limb. Riders without independent posture control may ride only if accompanied by a Supervising Companion.

**Attraction Access** - Riders must be able to transfer into ride vehicle through a narrow opening. Ride area is wheelchair-accessible via a ramp in front of the attraction. Service animals are permitted on this attraction.

# **Flying Galleon**



**Height/Age Requirements** - Riders must be 48" tall or accompanied by a Supervising Companion. Riders under 10 years of age, who meet the height requirement, must be accompanied by a Supervising Companion. A Supervising Companion may accompany no more than two (2) children who is under the height requirement to ride alone.

**Physical Requirements** - Riders without independent posture control may ride only if accompanied by a Supervising Companion.

Other Restrictions - Guests who are pregnant shall not ride.

**Attraction Access** - Riders must ascend and descend stairs to enter and exit ride area. Guests utilizing SNAP should press the button near the exit gate to notify the operator of your presence. Please wait outside of the exit gate and DO NOT enter the ride area without the ride operator's consent. Service animals are permitted on this attraction.

#### **Ghost Ship**



Age Recommendation - Attraction not recommended for children under 10 years of age.

**Attraction Access** - Guests using ECVs must transfer to a wheelchair. Guests using crutches must transfer to a wheelchair. Please see Attraction Attendant for information on wheelchair rentals. Attraction is wheelchair-accessible via a ramp at the exit. Press the button at the top of the exit ramp to notify the operator of your presence. Please wait outside of the exit gate and DO NOT enter the ride area without the ride operator's consent. Service animals are permitted, however given the frightening and unpredictable nature of this attraction, they are not recommended.

#### **Giant Wheel**



**Height/Age Requirement** - Riders must be 56" tall or accompanied by an Adult. Riders who are under 10 years of age, who meet the height requirement, and persons with developmental disabilities must be accompanied by an Adult. One Adult may accompany no more than two children. Single riders are not permitted.

**Physical Requirements** - Riders without independent posture control may ride only if accompanied by an Adult

**Attraction Access** - Riders must be able to enter and exit a ride vehicle that will move while entering and exiting. Ride area is wheelchair-accessible via a ramp at ride entrance. Service animals are permitted on this attraction.

# **Hangry Seagull**



Height Requirement - Riders must be 36" tall to ride.

Physical Requirements - Riders must have at least one leg.

Casts/Braces - Guests with cervical collars or neck braces shall not ride.

Other Restrictions - Guests who are pregnant shall not ride.

#### Henekee



Height Requirement - Guests over 56" tall are not permitted to ride.

**Physical Requirements** - Riders must exhibit independent posture control. Riders with amputations of both legs may only be permitted to ride in enclosed vehicles.

Attraction Access - Ride platform is elevated above ground level.

# **Kiddie Swings**



**Height Requirements** - Riders must be 36" tall to ride. Guests whose feet can touch the ground once seated or who are over 54" tall are not permitted to ride.

**Physical Requirements** - Riders must have two lower limbs to be securely restrained by straddling the restraint strap.

Attraction Access - Riders must be able to enter and exit a swing that will move while entering and exiting.

# **Kite Flyer**



Height Requirement - Riders must be 42" tall to ride.

Casts/Braces - Guests with cervical collars or neck braces shall not ride.

**Other Restrictions** - Guests who are pregnant shall not ride.

#### Mini Scooters



Height Requirements - Riders must be 36" tall to ride. Guests over 52" tall are not permitted to ride.

**Physical Requirements** - Riders must have the ability to steer and depress the pedal or may ride as a passenger with another rider who meets all rider requirements. All riders, including passengers not driving a vehicle, must be able to brace with at least one functioning leg.

**Casts/Braces** - Guests with cervical collars or neck braces shall not ride. Riders with casts on both arms may only ride as a passenger.

**Attraction Access** - Riders must be able to enter and exit a ride vehicle that will move while entering and exiting. Ride area is wheelchair-accessible via a ramp at the attraction's exit. Please wait outside of the exit gate and DO NOT enter the ride area without the ride operator's consent.

# **Moby Dick**



**Height Requirements** - Riders must be 48" tall to ride alone. Riders 42"-48" tall must be accompanied by an Adult. Guests under 42" tall are not permitted to ride.

Physical Requirements - Riders must have at least one lower limb.

**Casts/Braces** - Guests with cervical collars or neck braces shall not ride. Riders with arm or leg casts may ride if the cast does not interfere with the proper functioning of the flight suit.

Other Restrictions - Guests who are pregnant shall not ride.

Attraction Access - Riders must ascend and descend stairs to enter and exit ride area.

# **SkyScraper**



Height Requirement - Riders must be 52" tall to ride.

**Physical Requirements** - Riders must be able to grasp/brace with at least one functioning arm and have two functioning lower limbs. Riders with prosthetic limbs shall not ride unless the prostheses are removed and the rider meets the listed criteria with the prostheses removed.

**Casts/Braces** - Guests with cervical collars, neck braces, full arm casts that cover the elbow, or full leg casts that cover the knee shall not ride.

Other Restrictions - Guests who are pregnant shall not ride.

**Attraction Access** - Riders must be able to enter and exit a ride vehicle that will move while entering and exiting. Ride area is wheelchair-accessible via a ramp at the attraction's exit. Please wait outside of the exit gate and DO NOT enter the ride area without the ride operator's consent.

#### **Spring Shot**



Height Requirement - Riders must be 50" tall to ride. Single riders are not permitted.


**Physical Requirements** - Riders must exhibit independent posture control. Riders must have two functioning upper limbs that extend at a minimum to the elbow and two functioning lower limbs that include the knee. Prosthetics must be securely attached and must remain secure under the dynamic forces of the ride.

**Casts/Braces** - Guests with cervical collars, neck braces, full arm casts that cover the elbow, or full leg casts that cover the knee shall not ride.

Other Restrictions - Guests who are pregnant shall not ride.

Attraction Access - Riders must ascend and descend stairs to enter and exit ride area.
