SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Move to fresh air. Keep at rest in a position comfortable for breathing. If breathing has stopped, trained personnel should begin rescue breathing. Call a Poison Centre or doctor. Specific treatment is required.

Skin Contact
