Veterans Benefits Payment Agreement

- 1.** The payment of veteran educational benefits requires that a student is actually enrolled for and attending classes. An enrolled student is one who has registered and paid the required fees.
- 2.** You must submit a copy of your VA form 22-1990 or 22-1995 to MSOE.
- 3.** You must submit a copy of your DD214 (Certificate of Release or Discharge from Active Duty) or NOBE (Selected Reserve Educational Assistance Program Notice of Basic Eligibility) with the Veterans' Certifying Official.
- 4.** You must submit transcripts of all previous coursework and military training for transfer credit/advanced standing to MSOE.
- 5.** If a student receiving VA benefits drops or adds courses or fails to reenroll in a quarter for which certification was requested above, it is that student's responsibility to notify MSOE's Financial Aid Office immediately. If such changes of course load or enrollment is not reported, the student will be required by law to refund the overpayment.
- 6.** All students are required to submit a Change of Program Form with MSOE's Registrar's Office if they change programs. This form will be forwarded to MSOE's Financial Aid Office to keep your records updated.
- 7.** All students are required to maintain a cumulative grade point average of at least 2.0. Students on academic probation will receive VA benefits for the quarter certified but will be reported to the VA.
- 8.** A veteran's educational benefits will be terminated due to non-attendance or non-participation in classes.
- 9.** A veteran may be certified only for required courses and electives needed for their selected program as specified on the curriculum.
- 10.** The MGIB (Chapter 30) recipients must verify his or her continuing enrollment on the last day of each month or within a week after by internet web: <http://www.gibill.va.gov/wave> or by phone: (877)-823-2378.
- 11.** MSOE will only award institutional gift aid including MSOE Academic Scholarship up to MSOE's cost of attendance after veterans educational and other federal and state gift aid has been applied.
