

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO

COVID-19/CORONAVIRUS

The novel coronavirus - COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Bobby Sox Softball/Vacaville Bobby Sox has put in place preventative measures to reduce the spread of COVID-19; however, Bobby Sox Softball/Vacaville Bobby Sox **CANNOT GUARANTEE** that you or your daughter(s)/grand-daughter(s) will not become infected with COVID-19. Further, **attending activities at the Vacaville Bobby Sox softball fields could increase your risk and your daughter(s)/grand-daughter(s) risk of contracting COVID-19.**

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my daughter(s)/grand-daughter(s) and I may be exposed to or infected by COVID-19 by attending activities at the Vacaville Bobby Sox softball fields and such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Vacaville Bobby Sox softball fields may result from the actions, omissions, or negligence of myself and others, including but not limited to, Vacaville Bobby Sox Board/volunteers, and other program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any such injury to my daughter(s)/grand-daughter(s) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense of any kind that my daughter(s)/grand-daughter(s) or myself may experience or incur in connection with our attendance and participation in activities at the Vacaville Bobby Sox softball fields.

On my behalf, and on behalf of my daughter(s)/grand-daughter(s), I hereby release, covenant not to sue, discharge and hold harmless Bobby Sox Softball/Vacaville Bobby Sox, it's employees/volunteers, agents and representatives, of and from Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Bobby Sox Softball/Vacaville Bobby Sox, it's employees/volunteers, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in the League.
