# Clyde Savannah Youth Basketball Program 

Meeting Minutes September, 17, 2007

- Opening Statements - Brett Carnevale (Varsity Boys Coach) discussed his vision for the future of the youth basketball program - consistency, goal is that the program is "for the kids". Ray Hendershot (Girls Varsity Coach) was unable to attend.
- Discussion was had_regarding past practices, successes and areas for improvement. Some of the concerns mentioned were why the program was now being organized by Mr . Carnevale and Mr. Hendershot and the need for equality between the boys and girls’ programs. There was agreement that the program would be combined, one program that will equally service both the girls program and the boys program. The finances will be joined with the current funds - boys currently have a balance of $\$ 5.00$ at WCTA and the girls $\$ 700$. in Lyons National Bank. The program will be called Clyde-Savannah Youth Basketball.
- Nominations - It was decided that board members would be able to coach. Nominations for :

President - after nominations a closed vote was held. Tom Kanaley was elected the program president.

Vice President - Jeff Shields was nominated but declined. Jeff Sharp was nominated, accepted and was appointed.

Treasurer - Sara Shields was nominated, accepted and was appointed.
Girl's Director - Jeff Shields was nominated, accepted and was appointed.
Boys Director - Ken Disanto was nominated, accepted and was appointed.

- Director- the responsibility will be to over see the travel leagues. The director will be the contact person for the leagues and will have the responsibility of contacting coaches to finalize game times and sites. The director will help in scheduling practices, finding area tournaments for the travel league to participate in. Their findings will be brought back to the board and committee for discussion on what events to participate in.
- Coaches - It was discussed and decided that the varsity coaches will appoint the coaches for the traveling and Saturday morning program.
- Finances - it was decided that the treasurer and the president will have to sign off on any expenses.
- Tom Kanaley - mentioned an organization out of Geneva that refs could be scheduled from for a fee of $\$ 22 . /$ game. It was agreed upon that this would be a good idea.
- Program Insurance - both the girls and boys programs insurances will be running out before the start of the new season. Jill Harper will contact Roxanne Kise/Don Colvin about the possibility of the Village helping to cover the liability insurance. Currently the insurance was held through (?) K\&K insurance.
- New Season for travel will be starting mid November for girls $7 / 8$ and boys $5 / 6$.

Review of Meeting Minutes from 9/17 - There were no corrections or additions. Jeff Sharp brought up for discussion that he felt that an individual on the board should have the ability to bring back to the board/committee any issues with the coaches that are assigned by the varsity coach if an issue should arise for further discussion. It was agreed that this would be procedure.

Open Discussion - Tom Kanaley discussed his excitement and optimism for the start of this new combined effort and the upcoming season. Jill Harper reminded the board/committee the need for any topic to be brought back to the board/committee for discussion and vote. Other than the varsity coach's having the ability to choose the coaches for the travel team, no one person will be responsible for the decision of practice/procedure of the program.

By-Laws - Some topics that will need to be addressed in the by laws are

- The number of meetings an individual will need to attend in order to have a vote.
- A process for gaining/loosing voting rights.
- Jeff Sharp will review and put together a rough draft of by-laws based from different organizations current by-laws.

Girls Information - League meeting on October 1 at Seneca Falls Rec. at 7:00pm. Jeff Shields and Ann Kelsey will attend. This is where the league rules will be adopted.

- 2006-07-5/6 travel girls had 12 or 13 players, 3 or 4 were cut.
- 2006-07 - $7 / 8$ travel girls had 12 players, 3 were cut.
- 2006-07 fees: 1 player for fundamentals was $\$ 25$, 2 players was $\$ 40$. If they made the travel team there was an additional fee of $\$ 10$. for a total of $\$ 35$.
- 2006-07 programs - Fundamentals (grade 2-6) there were a total of 48 players. This included 12 players from the $5 / 6$ girls travel team. The program ran for 6 Saturdays starting in December. There were 4 coaches and the JV/varsity players alternated weekends.
- 2006-07 Summer Camps - Grade 2,3,4 was for 3 sessions the end of June/early July. 9 girls attended. The fee was $\$ 15$./girl. Grade $5,6,7$ was for 4 sessions for 15 girls. The fee was $\$ 20.00 /$ girl.
- Admission tickets were sold for $\$ 1.00$ /adult excluding coaching staff.

- There was discussion that to date there is not a girl's varsity coach. Jeff Shields stated that he was not interested in coaching. Lynne Carnivale mad a motion that because of the short notice that the committee would name a coach for the $7 / 8$ girls travel team. Ann Kelsey would be the head coach; Kim King would be the assistant. It was agreed that Brett Carnivale and Tom Kanaley would go to the new girls Varsity coach and explain why we picked the travel coaches for $7 / 8$ girls. Next year the procedure will go back to the varsity coach naming the travel team coaches.
- Tournaments - last year the $7 / 8$ girls travel participated in a Xmas tournament in Penn Yan. People stated it was a good tournament. Parents paid \$10./girl. Another tournament was the AAU /Hobart tournament. The original fee is $\$ 400$. Last year the girls paid less as they filled in for a team that did not participate. This tournament was for girls $<11$ years old. Other tournments that Jeff Shields will look into are Macedon, Wayne and Marcus Whitman.
- Needs - basketballs, first aid equipment, scorebooks, white boards, balls for each child in fundamentals (Tom Kanaley can get for about \$6. each), coaches shirts
- Signups - $7 / 8$ grade girls travel need to hold tryouts in the next 10 days, second week in October. There was discussion about having 1 sign up day.
- Need to develop a brochure - anyone interested in helping please let Jill know
- Lynne Carnevale stated the 7/8 grade players who also cheer can leave cheerleading practice at 7:00 to go to basketball
- Brett Carnevale - will block off times for Sundays.

- 2006-07 Fundamental program - 50 kids total participated at $\$ 30$.

- Insurance - provided from Ely and Leene - Steve Felker at a cost of $\$ 350$ for all the programs and participants.
- Tournaments $-7 / 8$ - attended 1 tournament
$5 / 6$ - attended 3 tournaments, one was paid by parents
Fees- were $\$ 150$. each tournament
- Equipment - no expense
- League Fees - $\$ 10.00 /$ team
- TShirts - fundamentals, $5 / 6,7 / 8$ - $\$ 3.76$ each

- Referees - were volunteers. 5/6 travel team had 7-8 home games, $7 / 8$ travel team had 6-7 home games.

- Additional Expenses - Becoming Incorporated - about \$500., IRS non for profit about \$500-\$600.
- Incorporation - there was discussion about becoming incorporated using a general name so we could go for grants for all sports. We would need to work through an attorney to accomplish.
- Finances - It was unanimous that we would do our banking with Lyons National Bank.
- Sarah Shields will open a new account and get information for a tax Id number.
- Tom Kanaley will close the account at Reliant Bank.
- There was a discussion to use 2 signatures and have a third name for an authorized signature in case the president or treasurer is unable to sign. Jeff Sharp made a motion to nominate Jill Harper, it was seconded by Lynne Carnevale, all were in favor.
- Jeff Sharp suggested the boys raised $\$ 700$. to raise funds to equal the girls current funds.
- First aid - there was discussion that all coaches should be trained in first aid/CPR. Jeff Sharp made mention a program at the Seneca Falls Rec Center. Jill Harper could also teach.
- Fundraiser Meeting - Meeting to be held $10 / 3$ at $6: 00 \mathrm{pm}$ at the bleachers down at the football field. Ideas discussed were a bottle and can drive, lottery tickets, chicken BBQ.
- League Calendar - there was a discussion about the benefit of developing a league calendar, if anyone is interested in this job please let Jill know.
- Fundamentals-there was a discussion that the fundamental program should also include the $5 / 6,7 / 8$ travel teams.
- Coaches - there was clarification that travel team coaches are limited to those chosen by the varsity coach and that any additional help would have to be approved through the varsity coach. In the fundamental program as many coaches as possible are welcome.

Review of 9/24 Meeting Minutes - Minutes were reviewed by Tom Kanaley. There were no corrections or additions made. Minutes were approved as is.

## Unfinished Business-

Budget - there was discussion of the proposed budget.

- There was thought that the $\$ 800$. figure for insurance may be high. Tom Kanaley/Jeff Sharp will review insurance coverage/expense with Steve Felker.
- Registration Fee - Discussion was held that last year's fees were $\$ 30 / \$ 60 / \$ 75$.

Tom Kanaley motioned to make the registration fee for 1 child $\$ 30$. This was $2^{\text {nd }}$ by Marty Wright. After further discussion Lynn Carnevale made a motion that was $2^{\text {nd }}$ by Marty Wright. Fees will be :

- 1 child - $\$ 30$.
$=2$ children $-\$ 60$.
$=3$ children - $\$ 70$.
$=$ Travel League fee will be capped at $\$ 70$. per family
$=$ There will be an additional fee of $\$ 15$. for Travel participants who participate in the fundamental program.
$=$ Fundamental program is for $2^{\text {nd }}-6^{\text {th }}$ grades
- Admissions -admissions will be $\$ 1.00$ for an adult, students will be free.
- Concessions - there was a discussion about whether the concession stand would be profitable. It was agreed that the concession stand could be profitable if there is more than one game scheduled. Jeff Sharp made a motion to put concessions under the fundraising committee's responsibilities. This was $2^{\text {nd }}$ by Marty Moilsani.
- Referee Fees - Tom Kanaley discussed that the fees may be different from the $\$ 22$. charged last year through the CYOAEU. Tom Kanaley is to get the referee contacts to Jeff Shields and Ken DiSanto.
- First Aid Kits - it was agreed to make the cost $\$ 75.00$ for all 6 levels - $7 / 8$ girl travel, $5 / 6$ girls travel, $7 / 8$ boys travel, $5 / 6$ boys travel, girls fundamental, boys fundamental.
- Balls - It was agreed to use $\$ 100.00$ for each travel program to purchase 6 balls for each of the 4 teams.
- Tournaments - each travel team has budgeted funds for 3 tournaments.
- Shirts - it was agreed to not purchase shooting shirts for the travel teams this year. This will be a savings of $\$ 400$. in the proposed budget. The fundamental program will purchase shirts.
- Corporate Sponsorship - Because the budget shows a deficit of $\$ 1200$. There was a discussion that we could look for sponsorships from local businesses. There was mention to require at least a $\$ 100$. donation in order to get the businesses name on a t-shirt. Marty Wright offered to
work on this endeavor. This item was tabled until the next meeting. Bank Account - Sara Shields reported that she opened the new account at Lyons National Bank on $10 / 2 / 07$. The first order of checks was free. The initial deposit was for $\$ 733.67$. Jill Harper needed to sign the application. This was done on $10 / 2$.


## New Business-

By-Laws - the rough draft completed by Jeff Sharp were distributed. The request was for everyone to read and review and to be ready to discuss at the next meeting.
Girls Meeting on 10/1- Jeff Shields and Ann Kelsey attended the meeting on 10/1. Jeff reported that there will be a minimum of 15-16 teams.

- The teams will be divided into large/small school divisions. The teams in our division will be Clyde-Savannah, Lyons, Red Jacket, Marcus Whitman, and Romulus, Canandaigua - grade 7, Midlakes.
- End of the year tournament - There will be divisions of the top 4 teams and the bottom 4 teams. Each team will be guaranteed 3 games.
- Director to do: notify the other teams that we will have an admission fee and concessions available.
- There may be no more than 2 JV players on a travel team roster.
- There will be a 12-14 game schedule.
- League registration have increased from $\$ 175$. to $\$ 200$. for each $5 / 6$ grade travel and 7/8 grade travel. $7 / 8$ grade girls travel dues are due 10/15/07. If paid after that date the fee will be $\$ 225$. The $5 / 6$ grade girl's travel dues are due by $12 / 15$. If paid after that date the fee will be $\$ 225$. This fee still includes one tournament per age level. Lynn Carnevale made a motion for Sara Shields to pay both of the girls travel teams league fees. This was $2^{\text {nd }}$ by Karen Langworthy.
- $7 / 8$ grade girls travel - start $11 / 3$ with a tournament the $1^{\text {st }}$ week in January.
- 5/6 grade girl travel - starts the first week in January with a tournament the last weekend in February. Jeff Shields will clarify if the tournament will be Feb. 23, 24 and 25. The tournament will be scheduled around all county.
- Jeff Shields is looking at a $7 / 8$ grade girls tournament in Seneca Falls the first weekend in March and a Xmas tournament in Pen Yan. Steve Speno is to send more tournament information. Jeff Shields is aware of about 15 tournaments between January and April between Syracuse and Rochester.
- Girl's insurance- is good through 11/14/07.
$=7 / 8$ grade girl's travel- announcements to be made Wed-Fri (10/3-10/5) for interested $7^{\text {th }}$ or $8^{\text {th }}$ grade girls to come to the high school gym on Sunday 10/7 for tryouts.


## Travel Team Criteria-

- A question was raised if an $8^{\text {th }}$ grade player can do JV and the travel team. The boys will have an $8^{\text {th }}$ grader on JV. This discussion was tabled for another meeting.
- After discussion on who could play on the $5 / 6,7 / 8$ grade travel teams, Lynne Carnevale made a motion to keep registration to the appropriate age levels unless we can not find the numbers needed in the appropriate grade levels. Then we will open up to the next age group for a tryout. This was $2^{\text {nd }}$ by Patty Sharp.

Review of $10 / 2$ Meeting minutes - Minutes were reviewed by Jill Harper. There were no corrections or additions made. Minutes were approved as is.

## Unfinished Business -

Budget - Jeff Sharp noted the changes to the budget.

- He took the travel teams shooting shirt fee out for a savings of $\$ 400$.
- He was able to take out the purchase of balls for the girls travel team as Marty Molisani was able to secure a donation of 12 girl's basketballs for a savings of $\$ 360$. A thank you note will be written.
- He was able to decrease the estimated cost of first aid kits to $\$ 75$. for a savings of $\$ 150$.
- The new budget showed a deficit of $\$ 1231$.
- There was discussion lead by Tom Kanaley that he had spoken to K\&K insurance and based on 100 kid participation the estimated cost for insurance coverage is around \$550-\$600.
- There was a question raised if we should go through Steve Felker or directly through K\&K Insurance in Texas. Tom Kanaley will call Steve Felker and ask him to shop around for comparison figures.
- The possibility of a banquet was discussed. It was agreed that we would wait to a later date to see how the fundraising committee was doing.


## Girl's 7/8 Grade Travel Team

- Announcements were made $10 / 4$ and 10/5. Posters were hung at the Jr. /Sr. high school.
- There was an informational meeting held on Sunday $10 / 7$. 12 girls attended. Half were $7^{\text {th }}$ graders.
- The first practice will be Sunday $10 / 14$ from 4-6 at the high school, $10 / 15$ from 7:30-8:30 at the Clyde Elementary and 10/16 form 7:30-8:30 at Savannah Elementary. If there are no new girls that come to practice there will be no tryouts/cuts. If cuts need to be made this will be done on $10 / 17$. There are 12 uniforms available.
- TomKanaley will come up with a registration form and get it to Ann by 10/14.
- Ann Kelsey has a form the girls used last year to help with selection of the team/cuts. It was suggested that this form be used for both boys and girls.
- Lynn Carnevale made a motion that the selection of the team be made by the coaches. This was $2^{\text {nd }}$ by Jeff Sharp.
- It was stated at the information meeting that there would be 12 girls on the team.
- Announcements will be made 10/10-10/12 (Wed.-Fri.) about the first practice on $10 / 14$ and that all $7^{\text {th }}$ grade girls are welcome to attend. Ann Kelsey will email Tom Kanaley the poster and he will hang up at the high school.
Numbers on Team -
- Jeff Sharp made a motion to keep the maximum number on the team 12. If there is a special circumstance such as having 13 or 14 trying out then the coach needs to bring that situation/exemption back to the board. This was $2^{\text {nd }}$ by Tom Kanaley and all were in favor.
- Brett Carnevale made a motion to have a minimum on the team be 10 . If there is less that 10 trying out then it will be opened up to the entire next grade for open tryouts. This was $2^{\text {nd }}$ by Jeff Sharp and all were in favor.
Fundraising - will be for the travel participants only. report was given by Sue DiSanto
- The main source of fundraising at this time will be to pursue local businesses for financial support of the program. She has 3 different styles of letters to choose from. At this time there are at least 50 businesses that will be contacted. Jeff Sharp asked to see the letter choices before they go out. Sue will discuss with Marty to see what businesses he wants to had deliver to. A motion was made by Jeff Sharp to go forward with the letter writing solicitation (being signed by Tom Kanaley). It was $2^{\text {nd }}$ by Tom Kanaley. All were in favor.
- Sara Shields discussed the need to track expenses, keep receipts in order to be refunded out of pocket expenses.
- The thought is for any business that donates more that $\$ 100$. the organization will place their name on the fundamental shirt and advertise their support in the local pennysaver. Tom Kanaley stated the he had been able to fit 23 businesses on the back and sleeve of a previous shirt.
- Concessions stand would be profitable on double game days with a $50 / 50$ raffle.
- A bottle and can drive will be on hold at this time because the formal registration had not yet occurred and this limits the number of volunteers.
- Lottery card may be held mid season or next year. Because the target number of sales are 1000 tickets and only 48 participating travel players each player would have to sell 20 tickets at $\$ 5.00$ each or 10 tickets at $\$ 10$.
- Boys Program - Jeff Sharp suggested that the boys program do the bottle and can drive to make up the $\$ 733$. deficit. He will be contacting participants.
By-Laws - a motion was made by Butch Carnevale and $2^{\text {nd }}$ by Sara Shields to form a sub committee to further discuss the rough draft of the by-laws. All were in favor. The committee members will be George Bastedo, Jeff Sharp and Marty Molisani.
New Business
PO Box - Sara Shields was given permission to go ahead and open a PO box at the Clyde post office. The cost will be about $\$ 58$.
Registration - will be held Saturday 10/20 from 10-12 at the high school gym foyer.
- Tom Kanaley to put in a building use form for the foyer and check to see if this is the weekend of a volleyball tournament.
- Jill will put together a contact list for name/phone number for any interested volunteers to have available at registration.

- Tom Kanaley to put together a flyer to send home with students grades 2-8 this week.
