4. New Business:

- Chain of command review

 - To be sent directly to Chandler who will work with VP/President as needed.
- Referee pay when weather strikes (Chandler)
 - Historically, when a game is cancelled, the ref is still paid for canceled game plus the next game.
 - Need to add policy to rules in June
 - Also need to discuss raising ref fees to be more competitive with other associations. (Discuss during May meeting) Chandler would like to hold camps over the summer to help fund increase in pay. Chandler to present full proposal in May's board meeting. May also need to increase registration fee to cover this increase.
