2012 PLAYER'S WAIVER AND CONSENT

Warranty of Player's Fitness

The undersigned (hereinafter, "the Player") hereby warrants to the Men's Senior Baseball League, Inc. and the San Antonio Men's Senior Baseball League (SAMSBL) (hereinafter, "the League") that he is eighteen (18) years of age or over, is in good physical condition, and that he has no impairment, ailment, or legal reason preventing him from engaging in the activities of the League.

Absolute Release of Liability

In consideration of being permitted the privilege to participate in the activities of the League, in any manner, including but not limited to playing, practicing, coaching, spectating, or being on the field or in spectator areas for any purpose whatsoever, with a full understanding that participation in the game of baseball includes the risk of serious personal injury, the undersigned Player assumes full responsibility for the risk of injury of any magnitude including fatality due to his participation, or from other participants, weather conditions, playing conditions (including the type of bases, plates, fences, and equipment), and does hereby forever absolutely release and agrees to hold harmless the Men's Senior Baseball League, Inc., and the SAMSBL (owner and officers), and all government bodies, agents, servants, officers, public officials, volunteers, game officials, and sponsors from all claims for any damage or injury whatsoever of any kind or in the future.

Player's Participation in the Local League and National, State, and Local Tournaments

The Player shall participate in the League as a member on a team for two (2) full years known as (_____) (+) _____, which is a team in the SAMSBL. As a member of the League by virtue of this properly executed waiver, the Player agrees to abide by any and all League Rules and Regulations. As a member of the League, the Player shall be eligible to participate in Local, State, and National Tournaments, as organized by the League, according to the regulations promulgated by the League. The Player acknowledges that he must play in 50% of all regular season SAMSBL games in a given year to qualify for that year's participation in any type of Tournament. The Player further acknowledges that he will play the game of baseball with class at all times and adhere to the high standards published in the Code of Conduct Section of the SAMSBL Rules. The Player further acknowledges that he must obtain a release from the League in order to participate on a tournament team against (or not with) the League. The Player recognizes, as a member of this organization, the authority of the League President and Board of Directors to determine and enforce organizational policy. The Player agrees to abide by all rules and regulations as set forth by the President and/or the Board of Directors including the presence of tobacco products, alcohol, or inappropriate behavior, language, or mannerisms at any site.

Image and Reputation

The Player consents to being a member of the SAMSBL with all the privileges thereof, upholding the Code of Conduct method of playing baseball at all times. The Player acknowledges the Image and Reputation of the SAMSBL are both important and fragile. The Player agrees to protect them both all times while a member of the SAMSBL, locally, across the state, or nationally. For those Players who are of legal age to drink, where drinking of alcohol beverages (prior, during, or after a game) is prohibited, the Player agrees to adhere to the League policy. Further, the Player agrees he will not participate in any SAMSBL Image-detracting incident or situation. The Player acknowledges that fines, suspensions and expulsions can result from such action.

Limitation of Liability

The Player shall participate in the League's programs and/or use any of the League's facilities, services, or equipment at his own risk. The Player waives any and all claims, of whatsoever kind or nature, that may arise against the League as a result of the Player's participation in any local, state, or national League's recreational baseball program. The Player also acknowledges recognition of the National MSBL and SAMSBL rules and regulations and agrees to abide by them at all times. The Player further acknowledges the "helmet" requirement that all batters, base runners, catchers, and base coaches must wear protective headgear at all times. The hitters are encouraged to wear a double-ear flap helmet while at the plate, but are required to cover the temple facing the pitcher should the hitter choose to wear a single flap helmet. The catchers are required to wear a protective skull cap, at least, at all times. Base coaches are required to wear a double-ear flap helmet at all times while in the coach's boxes. Finally, the Player acknowledges recognition of the fact that neither medical nor liability insurance is inherent with local or national membership. Medical and Liability Insurance are made available to SAMSBL through the National organization through the League President correspondence. Medical Insurance has an additional cost factor that is borne solely by the Player, should he choose to do so.

I, the Player, have read this release and consent waiver and understand that it is an absolute release and I freely and voluntarily accept its terms and understand it is binding upon me, my heirs, spouse in interest and assigns.
