Zebra web: Schedules have been dropped. We are still in infancy stages of Zebra web. Mike Hogan, Anne Fahey and Chris Hahn have been diligently working alongside Assignor Megan to schedule assignments. We only have three officials who reside on East end; please accept Eastern Suffolk Assignments as well. **Scrimmages:** Kevin

Chilton has all the preseason scrimmages listed on website. Please sign up. All Officiating levels welcome. Best way to fine tune mechanics, positioning, foul and violation recognition, rule knowledge, play calling is to work a scrimmage prior to first game. Mandatory for Varsity to participate in (2) 3-Man scrimmages-Northport 11/25, Babylon 11/29. From the floor asking permission to orchestrate a three man scrimmage on listed scrimmages-yes. Must have three man scrimmages to work Playoff game. Need experienced Varsity officials to volunteer to run three man scrimmage.

Ejection/Technical Foul Report: If you eject or call a technical foul fill out the the Google Form Sheet found on website, the night of or day after. All Associations are keeping misconduct data to be presented to Section XI for contractual leverage.

Disruptive Fan: If there is a loud belligerent fan in stands, Section XI is mandating that official stop game, notify head coach to alert security to warn fan. If conduct continues, stop play, approach coach again, to get security to remove fan from stands. Make every effort Get person's name from security. 'Fan Ejection Protocol' sheet is on website. Please familiarize yourself with it prior to season. Follow the protocol advised, in anticipation of security not completing their task.

Game Day Requirements: Text or call your partner on game day. All Partners contact information is included on Zebraweb game. **Uniforms:** Everyone wears jacket, striped shirt, black pants black sneakers Look presentable, perception very important.

Late Fees- late start time determined by Arrival time of visiting team bus. Late start begins with 20 minutes /\$30. 40 minutes pass game time Both officials may leave and get paid for full game. Document everything; Fill out Extra Compensation Forms right away.

Sexual Harassment: Officiate with your whistle, be smart. Mike Hogan reviewed aspects of potential sexual harassment. Use common sense. Stick to the rule book.

John Pirodato- former official now the new Athletic Director at Central Islip. Will assist in evaluating officials at C.I. games. There are a number of officials on radar who may not have been rated to their ability.

Committees: Ethics, Ratings, Elections, CYO, Movement, Attendance we added **Recruitment** -chaired by James Kavanaugh; all association members should make effort to recruit new blood. We had 12 new candidates this year.

Insurance and Game Fee Loss-After extensive research by Maureen Lipshie, Mike Hogan and Anne Fahey we are switching insurance carriers this year: more coverage and game fee loss. If you are injured during season you will be compensated \$100/game missed, up to \$500/week and \$3000 for season.

Lockerrooms: Mike Hogan will contact Pete Blieberg from Section XI to reaffirm adequate changing areas for officials.

Rules Update: Pat DiClemente:

Pat DiClenmente advocated Zebraweb app for game day notifications to your partner: all pedigree information is there. Livestreaming games: Districts often stream games at every level now. Please be cognizant, If you have a subscription to HUDL you can rewatch and personally

reevaluate yourself. Season is upon us. Get uniforms in order, participate in scrimmages and look at Rule Book. 11/25 and 11/29 Three man Scrimmage and Candidate Floor Test. On State Exam questions came directly from Pre Test and appeared recycled points of emphasis. Review: Jurisdiction begins 15 minutes before tip off and ends when we approve the Final Score. Don't hang around gym once game over. Final horn point to table confirm final score. At end of regulation each coach gets additional 30 second time out. OT is ½ of a quarter; (4) minutes; re-jump and fouls carry over. **Airborn**-going outbounds, can not call time out to bail out. There must be an arrow at the table. **Advancing the Ball- Less than 59 seconds** Team has not dribbled or passed the ball calls a time out. By rule Coach must notify us on advancing prior to time out. As officials we can prompt it by asking if advancing and from where. **Inbounding the Ball:** As lead on **sideline** we are bouncing the ball **Endline**-hand off staying home. Always whistle on the inbounds. **Player with ball makes contact with someone on sideline**-whistle stop play, goes other way.
