#### 2017 Fall Softball

Fall Ball going OK. Difficulty getting umpires. **Action Item:** Bob Burchell will send email out to all WWSO coaches to drag fields after last game of the day.

#### **Barness Improvements**

Opportunity to put a fence on Low Minors field and make it a 200' field. Need to work with

Field Hockey to see if they will move to accommodate if this is something that is desirable. Purpose of adding a fence will be so that we can run more tournaments at Barness. **Next Step:** Ed Sablich will get pricing.

Shed along the first base side of Majors Field. Already have pricing and it's been approved at a prior Board Meeting. Shed will hold Sandpro, liners and field mix for Instructional and Low Minors divisions. **Next Step:** Ed Sablich will talk to Township for approval.

### Field Preparation/Maintenance

Discussion on hiring someone to prep and line the fields. General consensus is that it is a good idea but we don't know anyone who to do it. **Next Step:** Bob Burchell will post ad in 2 places (Craigslist and Nextdoor).

## **Pitching Clinic**

11 weeks starting in January. 5 week session and then a 6 week session. **Next Step:** Ed Sablich will give Bob Burchell the information and Bob will create the registration form and send out the registration email.

## Sunday Select/Suburban League Participation

#### **Volunteer Tracking**
