2-4-3
It is NOT necessary to throw 4 intentional balls



Defensive coach or the catcher may request this

Be sure to signal and call time – play is dead – when recognizing this request

2-8 Bunt Batter does not swing to hit the ball, but holds the bat in the path of the ball



To charge a strike the batter must have offered at the ball not just held the bat out over the plate – you can distinguish this – this can be an appealable play if U1 doesn't see it.

Reminder a bunted ball that goes foul with two strikes is an out.

2-9-1

Controlling a catch - fielder MUST demonstrate complete control of the ball and that his release is voluntary and intentional



Outfielder lays out for hard liner or looping fly – ball in glove and slides a bit and ball a) comes out of his glove b) he transfers ball from glove to open hand and subsequently the ball falls to the ground -- what options do you have?

I know its easier to see than just discuss – but lets try

- a) No catch
- b) You need to judge if he released from glove to hand then dropped or if the drop happened during the transfer

2-22-3 Obstruction at a base — Fielder who does not have the ball may




Can happen at first base – the runner needs some access back to the base



2-22-3 Being in the act of catching the ball is not possession. The fielder is not allowed to deny the runner access to the base.

2-32-2 slide
Runner can slide feet or head first
Feet first – he must slide

- with at least one leg and buttocks on the ground
- Within reach of base with a hand or foot
- May slide away from the fielder to avoid him



When an illegal slide happens and runner alters the actions of the fielder - runner will be declared out (dead ball interference) – additionally the trailing batter runner shall be declared out

NOTE – 8-4-2-d runner may not dive over a fielder - runner out ball remains live unless interference is evident.



3-2-2 assisted runner
Coach may not physically assist a runner or prevent his advancement during a live ball —
By pushing him toward a base or back to a base
Accidental collision is not assisting -

Delayed dead ball – additional outs apply - at end of the play – call time – declare the runner out may be the fourth out - All runners not put out return to base occupied at the time of

the infraction – this may be hard to discern

3-3-1g

Assistant coaches may NOT leave the dugout or coaches box to argue a call - only the head coach may approach you.

Kindly present that to an assistant coach that approaches you for "complaining"

Penalty will be restricted to the bench - or if egregious then ejection (try to avoid)

3-4-2 Offensive conference

Team gets only one per half inning –

Just deny subsequent requests



Reminder - offensive team requests a conference – while coach is talking to batter or runner -- Defensive team coach may come onto the field to confer with his players – defensive coach must leave field when offensive conference ends

3-4-1 Substituting

Hopefully – substitutes are announced to U1 announces it to opposing team -



However – an unannounced substitute is valid has assumed the position – batter takes place in batters box, fielder goes to his new position, runner takes place of another runner (that one is seen) - it becomes official when noticed

Example: top of 4th inning Smith replaced starter Francis in right field but is not announced. Bottom of 4th inning - Smith comes to bat and gets a hit – TeamB declares Smith batting out of order -- after researching you determine that Smith was a valid substitute for Francis. No Penalty – fix the scorebooks and carry on.
