VI. Open Issues

1. Player Releases-

2. Jason Dalton (WT) is not allowed at tournaments or league games and may only attend a SOSLI game if there is an immediate family member playing. There was a meeting with him and he promised to do as asked. WT will not be allowed to host tournaments for a year for due to what he did.

3. Baseball umpires can come to the meeting for umpires for experienced umpires and get clickers and rulebooks. We won't use umpires in tournaments that are not at these meetings. Umpires need certified. Umpires can be approved by each park but they need to know SOSLI rules.

4. Player Exception Committee and Player exceptions:

-grade level and age which is listed on website too.

-talk about this more in the fall starting with this year's kindergarten class start this age adding them in each year one at a time by grade level. We will need to decide to go by age or grade, we cannot grandfather kids in.

5. Exceptions:

-Williamsburg requested 6U first grader 4/17/12 DOB be approved. All reps approved and voted "YES" to this exception.

-Eastern requested two new players who are sisters be approved for 8U with DOB 1/11 (3rd grade) and 2/10 (4th grade). The grade plus age puts the 2/10 sister over for 8U but would give enough for an 8U team. All votes are "NO" for these two players.

-Felicity requested a first-grader that wants to play 6U and misses the DOB by a month. All reps approved and voted "YES" to this exception.

-Lynchburg requested a 9U 3rd grader who is a first year player with a DOB of 4/25 misses the cutoff by 3 months. All votes are "YES" and approved this exception.

-Mt. Orab requested 6U for a 1st grader who has a DOB putting her two days over the requirement and in 7U. She wants to play 6U. All reps approve and voted "YES" to this exception.

-Williamsburg has two girls who were 10U last year and are in 5th grade and hope to play 10U again because they are 5th graders to the present and age 11. DOB for these two: 6/28/08 and 7/28/08. All reps approved and voted "YES" to these two exceptions.

*These kids that are exceptions and are approved as exceptions cannot dual roster.
