**ARTICLES OF INCORPORATION OF
FORT CHERRY YOUTH FAST PITCH**
A Pennsylvania Nonprofit Corporation

In compliance with Section 5306 of the Pennsylvania Nonprofit Corporation Law of 1988, as amended, the undersigned incorporator states:

Article 1. The name of the corporation is Fort Cherry Youth Fast Pitch (hereinafter, the "Corporation").

Article 2. The address of the corporation's initial registered office is:

McDonald, PA 15057
Washington County**

Article 3. The Corporation is incorporated under the provisions of the Nonprofit Corporation Law of 1988, as amended, to develop and provide supervised and competitive youth girls softball opportunities to girls in the Fort Cherry School District and/or surrounding areas and to promote hard work, discipline, good sportsmanship, honesty, strength and courage.

Article 4. The Corporation does not contemplate pecuniary gain or profit, incidental or otherwise.

Article 5. The Corporation is organized on nonstock basis.

Article 6. The Corporation shall have no members.

Article 7. The name and addresses of the incorporation is as follows:

Article 8. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding section of any future Federal tax code.


Article 9. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees or officers, or to other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the Corporation shall be the carrying on of

propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Code, or the corresponding section of any future Federal tax code, or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Code, or the corresponding section of any future Federal tax code.

Article 10. Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or the corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is located at the time of dissolution, exclusively for such purpose or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes.
