- 3. School acknowledges that, as with all physical education activities, there is a risk of injury to participants.
- 4. General Release/Indemnity/Hold Harmless: Customer (school) understands and acknowledges that play on any amusement device/equipment entails both known and unknown risks. Customer (school) hereby voluntarily and expressly releases, indemnify, forever discharge and hold harmless SAUNENIN GRADE SCHOOL AND/OR SAUNEMIN FITNESS CENTER, it's agents or representatives, SAUNEMIN ATHLETICS, it's agents or representatives, VILLAGE OF SAUNEMIN, it's agents or representatives, from any and all liability, claims, demands, causes or rights of action whether personal to me or to a third party, which are in any way connected with participation in this activity, including those allegedly attributable to negligent acts or omissions.

ADDITIONAL TERMS & CONDITIONS

- 3. EQUIPMENT, RENT, PAYMENT, AND TERM OF RENTAL AGREEMENT: Customer (School) rents equipment described. The rental fee set forth is payable, in full, upon delivery of equipment.
- 4. PAYMENT: Customer agrees to pay full amount by cash, or by check made out to: Eagle Athletics.
- 5. DAMAGE DEPOSIT: Customer agrees that renter agrees to a 'No Damage Deposit' agreement with Customer (School).
- 6. USAGE: At this time, equipment is limited to INDOOR USE. Customer should make sure, within their ability and limitations, that area where equipment is being used is free of hazardous obstacles that could pose a potential puncture hazard of equipment.
- 7. DELIVERY: Equipment shall be delivered to the given address between 3:00-4:00 pm on the Friday prior to usage, OR, other arrangements may be made for weekend delivery depending upon provider needs or Customer needs.
- 8. PICKUP: Equipment shall be picked up between 3:00-4:00 pm on the final Friday of usage, OR, other arrangements may be made for weekend pickup depending upon provider needs or Customer needs.
- 9. CARE OF EQUIPMENT: Customer shall be responsible for any and all damage to any of the provided equipment, NOT caused by ordinary wear and tear. Damage that is NOT ordinary wear and tear includes, but not limited to, cutting or tearing of vinyl or netting, abuse, etc. Customer agrees that during the time of possession, if any individual piece of provided equipment is damaged beyond repair, the Customer agrees that an application of a replacement value fee of \$250 per individual piece may be applied and sought by provider.
- 10. USE OF EQUIPMENT: During the course of use, should any piece of provided equipment not function properly or in an assumed manner, Customer agrees to contact provider at their earliest convenience and will cease use of said individual piece of equipment. IF during the course of use any individual unit begins to deflate, Customer will immediately halt the usage of said unit and will begin process of checking for punctures or

finding reason for leakage.

- 11. RULES & INSTRUCTIONS FOR USAGE: A) Adult supervision is required at all times. B) Individuals with head, neck, back or other muscular-skeletal injuries or disabilities, those that may be pregnant, and those under a doctor's care that prohibits individuals from participating in such activities, should not be permitted in any individual piece of provided equipment at any time. C) Customer shall determine the most appropriate manner of storage for provided equipment that will keep provided equipment safe and free from potential misuse.
- 12. WAIVER: Customer (School) agrees that all potential users of equipment shall have on file, a copy of a provided waiver, for all users that are under the age of 18. Should said waivers not be filled out completely and signed as directed, said individuals will NOT be able to participate until completed waiver has been turned in to Customer (School) representative.
- 13. CUSTOMER ACKNOWLEDGEMENT: Customer acknowledges and certifies that they have had sufficient opportunity to read this Agreement, agree that they are an authorized representative of Customer (School), and agree to all terms and conditions as stated.
