- The minutes from the May 21, 2007 Executive Board meeting were read. Motion and second to accept the minutes as read. Carried.
- Bro. Vernell Bradshaw reported that the \$8,478.11 CD is mature and will be transferred to the Moark Association account this week. A remaining CD of \$2,444.59 will mature in December 2007 at which time it will be transferred.
- The Executive Board extended thanks and appreciation to Bro. Vernell Bradshaw for his hard work in taking care of the many aspects of the Central Building business this year.
- Bro. Bryan Johnson presented a written CE report. Bro. Bryan and Bro. David Wigger discussed the the February 16, 2008 CE conference that has been organized by the CE Board. Motion and second to accept the report. Carried.
