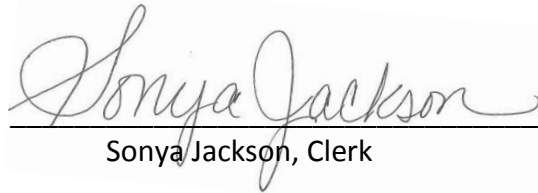
DIRECTOR OF MISSIONS REPORT
