COMMITTEE MEMBER LEADERSHIP RELATIONAL COVENANT

The heart of Christian ministry is Christ's ministry of outreaching love. Christian ministry is the expression of the mind and mission of Christ by a community of Christians that demonstrates a common life of gratitude and devotion, witness and service, celebration and discipleship. All Christians are called through their baptism to this ministry of servanthood in the world to the glory of God and for human fulfillment. The forms of ministry of this ministry are diverse in locale, in interest, and in denominational accent, yet always catholic in spirit and outreach.

The church stretches out to human needs wherever love and service may convey God's love and ours. The outreach of such ministries knows no limits. Beyond the diverse forms of ministry is the ultimate concern: that all persons will be brought into a saving relationship with God through Jesus Christ and be renewed after the image of their creator (Colossians 3:10). 10. I will participate in available training opportunities offered by my local church, district, and conference as it relates to my position as able.

If, I find that I am unable to keep this covenant, I will contact the Nominations committee Co-Chairperson to discuss my future in this role and/or understand the Nomination Committee's decision to reconsider my leadership position and or committee participation. I understand that I am a part of a team on a mission to make disciples of Jesus Christ for the transformation of the world and that the effectiveness of our work in the church and community depends in part on my commitment. I am thankful for the opportunity to serve and will train at least one other person to succeed me in this position. I serve God and the church with my best effort and will do all in my power to build-up and strengthen this part of God's kingdom on earth, so help me God.
