Proverbs 12:22 says, "The Lord detests lying lips, but he delights in men who are truthful."

The Bible mentions several ways we can be guilty of lying.

Perjury - Slander - Gossip/Rumor - Flattery - False Teaching - Careless Lies

Reasons why people lie

We lie to **protect self**.

We lie to gain an advantage.

We lie to impress others.

We lie to harm others.

Results of lying

First of all, lying harms others.

Secondly, lying destroys trust.

Thirdly, lying wrecks relationships.

Fourthly, lying ruins your reputation.

Fifthly, lying breaks your fellowship with God.

Finally, lying brings God's judgment on the liar.

Truth is ultimately in a Person. Truth has a name and that name is **Jesus**.

To know Jesus is to know the Truth.

To follow Jesus is to follow the Truth.

To believe in Jesus is to believe the Truth.

The ABC's of Salvation

(3 Step Process to Accepting Jesus as Savior)

A - Admit that I am a sinner (Romans 3:23, Romans 6:23).

B - Believe that Jesus is God's Son, that He died for me, and that His death can save my soul (John 3:16, Romans 5:8-10).

C - Confess that He is my Lord and Savior (Romans 10:9-13).

(Example of a prayer for you to follow)

Dear God, I understand that Jesus died on the cross for my sins, so I could be in relationship with You and go to heaven. I'm sorry for living a life without You at the center. Please forgive me for all my sins. I want to follow You for the rest of my life. In Jesus' Name, Amen.
