

## WORSHIP COMMITTEE MEETING

November 10, 2011

The meeting was opened by chairman Nancy Anderson with devotions by Cindy Lerohl.

1. It was decided to order bulletin covers for Thanksgiving and Christmas (2). Cost will be around \$35.00.
2. Ushers report – Preparations/needs in the barn for the JLG Architects' report were discussed.
  - a. Coffee will be after the presentation
  - b. 250 chairs to be available
  - c. Nancy will call Paul Lommen about extra lighting on the stage.
  - d. We need people who will help people down the ramps in the barn. Doyle will make sure that's covered.
  - e. Need to make sure we have good signage so people know our service is at the barn. Paulette to contact Chuck Hauck about door signs; Nancy to contact Holiday Inn about lobby sign.
  - f. Doyle will get someone to cover for him for services over Thanksgiving while he will be gone.
3. Altar committee report – 2 new helpers, Jayne Haglin and Marilyn Olson, have been recruited. The altar committee is a subcommittee and will not need to change members (only applies to heads of committees, not subcommittee). Discussed possibility of ordering additional banners – especially for advent/Christmas. Carla thought we may have some already – Gayle will check our supply of banners.
4. Coffee – We will begin to use Equal Exchange coffee for the coffee hour again once our current supply of regular coffee runs out. The problem of too many goodies for coffee hour was discussed. It was decided to buy cookies for Christmas Day coffee hour. AJ said he would clean up afterwards.
5. Discussed need for 30 additional small version of ReClaim Hymnal. While it's in the budget for 2012, the committee agreed that we sure could use them now rather than waiting 'til 2012. Pastor AJ will bring up to Executive Committee and make sure it's on the Council agenda for the upcoming meeting (cost would be \$500.00 total at \$17.00 each). If approved, they will be ordered right away.
6. Music committee – see written report. It was requested that copies of choir music no longer be made. We will simply order more copies. Note also that the Christmas Eve service (4:00 p.m.) will also be in the barn. Need to find out if we can use individual candles in the Barn for Christmas Eve. Nancy to check with Holiday Inn. (NOTE: Holiday Inn contacted – it's okay as long as the cardboard protector is used with the candles and no wax is dripped on the carpet.)
7. New/old business. We are booked at Holiday Inn through 2012 for services. Still looking at January 2012 for the trial on-line version of the ReClaim Hymnals to be available.
