Building & Maintenance Report

With the recent sleet and ice storm, our guttering sustained significant damage. Brotherhood Mutual, our insurance company, has let us know that the guttering is covered under the indoor water damage portion of the policy since it was damage related to ice. Our coverage is for up to \$25,000. Normally, our deductible would be \$2,500, but because this is our first claim under Brotherhood, we have a reduced deductible of \$1,875. Quotes have been received from Precision Guttering and Rain Solutions for replacing the damaged guttering on three sides of the building (N,S,W). Precision Guttering is the best use of our resources; have requested a modification to

the original quote to replace all guttering since other pieces are already loose and in danger of falling. We have less than 30 days to close the insurance claim.

Our parking lots are in need of being resealed to prolong their lifespan. We have received quotes from AAA Paving and Vincent Truesdale, and have requested a third quote from Ellsworth Paving. AAA Paving patched the north lot last year and Vincent Truesdale resealed the parking lot at Eden Chapel earlier this year. This will be a significant expense and we need to decide if it is one that should be undertaken this year as preventative maintenance for our property.
