Safety Procedures and Guidelines Phase One

The following is a list of our **Phase One** church move-in guidelines. These guidelines are meant to help ensure our church family, the leadership of this church has done more than what is required to ensure the safety of our church family during Phase One.

It is very important that our church family follow the Phase One Safety Procedures and Guidelines. Those who choose to attend must understand that their compliance with Phase One guidelines is necessary for the safety of others and the testimony of Priestley Chapel Baptist Church.

1. We will have the building cleaned using a professional disinfectant and infection solution to disinfect the facility following all CDC guidelines.
2. During Phase One, our church will not have Nursery, Children's Church, on-site Sunday school classes, onsite Bible Study or Choir.
3. Everyone is required to wear a mask. Should you not have a mask, Greeters will have some complimentary masks available as you enter the front doors, first come first serve.
4. Service leaders will wear masks and gloves when they are not on the platform.
5. Everyone will have their temperature taken by a touchless temperature scan. According to CDC guidelines, anyone 100.4 degrees or higher will not be able to attend.
6. We will have limited entrance into our church. Everyone is asked to enter through the Main Foyer entrance. We will exit using the main entrance and side door leading to the courtyard area.
7. We will have a touchless entrance and exit. Entrance and exit doors will be open using door stops.
8. We will have hand sanitizing stations throughout the building.
9. Households are asked to sit together.
10. We will have limited, socially distanced seating. Each pew will have 6' social distancing between attendees.

11. We will have restrooms available for emergency situations only. If there is a need, please use restrooms located in the front of the church. One person/family at a time will be permitted into a restroom; the restroom will then be cleaned before the next person will be permitted to enter.

12. We will not pass offering plates. Tithes and Offerings may be given in the offering plates located in the rear of the church as persons exit or online using **Givelify**. We ask everyone to download the **Givelify App** onto your phones, computers, iPads.

13. Words for the congregational songs will be projected on the screens.

14. We will continue to use pre-packaged disposable communion.

15. Persons making decisions for Christ will be Baptized individually.

16. All water fountains will be closed until further notice. Bottles of water will be available in the front foyer.

17. At the conclusion of the service, we will have an orderly dismissal; ushers will dismiss by row starting at the back and moving forward and from the front leading to the court yard, to eliminate situations where we would not be socially distanced.

We encourage persons with compromised immune systems, and those with underlying health issues, to continue to enjoy our online services and not attend services onsite during Phase One.
