Sue Frankewicz moved that the budget be amended to restore \$1,600.00 to the budget to put the Child Care Coordinator position back in. Ellen Cummings seconded the motion. Jan Larson offered a friendly amendment to the amendment that the \$618 for the Child Care Provider also be added back. This was accepted by the mover and the seconder. Bob Bunting offered a friendly amendment that we balance the two items by increasing the amount we take from our reserves. This was accepted by the mover and the seconder. The amendment was passed. The motion to approve the amended budget passed.
- 10. Motion to approve the Construction Bridge Loan. Clare Evento moved that the Construction Bridge Loan be approved; Erik Wingrove-Haugland seconded the motion. This motion requires a 67% approval. The motion passed.
- 11. Report from the Temporary Space Committee. George Dowker reported for the Committee, on their search for a temporary home during construction. The site that they have settled on is Temple Emanuel in Waterford.
