This Release and Waiver of Liability (the "Release") executed on this date _____

The Volunteer desires to work as a volunteer for Wildwood Soup Kitchen and engage in the activities related to being a volunteer (the "Activities").

The Volunteer understands that the Activities may include administering hygiene services, preparing and serving a hot meal, loading and unloading supplies and food, sorting donations, cleaning, performing building maintenance, driving vehicles, delivering meals and any other activities which may arise during the course of their service.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver: The Volunteer does hereby release and forever discharge and hold harmless Wildwood Soup Kitchen and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Wildwood Soup Kitchen.

The Volunteer understands that this release discharges Wildwood Soup Kitchen from any liability or claim that the Volunteer may have against Wildwood Soup Kitchen with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteering with Wildwood Soup Kitchen, whether caused by the negligence of Wildwood Soup Kitchen or its officers, directors, employees, agents or otherwise. The Volunteer also understands that Wildwood Soup Kitchen does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to, medical, health, or disability insurance in the event of injury or illness.

Medical treatment Volunteer does hereby release and forever discharge Wildwood Soup Kitchen from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Wildwood Soup Kitchen.

Assumption of the Risk: The Volunteer understands that the Activities may be hazardous to the Volunteer, including, but not limited to, food preparation and serving, loading and unloading, building maintenance, transportation, and any other activities which may arise.

The Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Wildwood Soup Kitchen from all liability for injury, death, or property damage resulting from the Activities.

Insurance: The Volunteer understands that, except as otherwise agreed to by Wildwood Soup Kitchen in writing, Wildwood Soup Kitchen does not carry health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her OWN medical or health insurance coverage and car insurance.

Photographic Release: The Volunteer does hereby grant and convey unto Wildwood Soup Kitchen all rights, title, and interest in any and all photographic images and video or audio recordings made by Wildwood Soup Kitchen during the Volunteer's Activities with Wildwood Soup Kitchen, including but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other: The Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by laws of the State of Florida, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Florida. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provision of this Release which shall continue to be enforceable.

Refusal to sign this release will result in my exclusion from participating in the Volunteer Program at the Wildwood Soup Kitchen.
