Motions Submitted

(1) Randy Conn, messenger from First Baptist Delta, MO presented:

Whereas in the course of history it becomes necessary to clearly articulate a once commonly held and understood biblical doctrine. And as the Church(the Body of Christ) is under attack by Satan and secularism and, whereas ambiguity permeates the association's governing documents. With a desire to eradicate any ambiguous language, and to ensure Godly standards are upheld. I therefore move that a committee be appointed to study the Constitution and Bylaws of the association, bringing recommendations to the 2019 annual meeting that will establish clarity and certainty of biblical doctrine.

Following discussion Randy Conn made the motion to approve, second by Matt Buttrum and approved by upheld hands.

(2) Credentials Committee
