### Cape Girardeau Baptist Association Executive Board Meeting – January 11, 2021

#### Motions from the Finance Committee

#### Motion 1:

To encourage good stewardship of financial resources, we move that year-end bonuses paid to ministerial staff will be based on the remaining balances in the ministerial Ministry Expense budget line.

#### Motion 2:

We move that the association creates a Building Maintenance Fund to ensure that funds are available to handle large and/or unexpected maintenance needs with funding allocated in the budgeting process. The fund should maintain a minimum balance of \$4000 and a maximum balance of \$10,000.

#### Motion 3:

We move that the PPP loan funds of \$24600, that have been forgiven, be allocated accordingly: \$15000 to cover the new roof, tree removal and the remodeling of the main level with the remaining balance going to the Building Maintenance Fund and \$9600 to the Association Partnership Missions Scholarship Fund.

#### Motion 4:

We move that the association creates an Associational Ministry Fund to be managed by the Associational Council with funding allocated in the budgeting process. This Fund would provide the association to ability to act upon unexpected ministry opportunities that may arise during the year outside of our normal budgeting process.

#### Motion 5:

We move that the rental income generated from the renting of the association building be allocated out by percentage to the Building Maintenance Fund, to the Associational Ministry Fund and to general income as part of the budget process each year.
