



Dear Brothers & Sisters in Christ,

Greetings in the name of our Risen Lord and Savior, Jesus Christ!

In 2015 we began a building project to expand the narthex of St. John Lutheran Church at a cost of \$694,463.00. The work done resulted in praise to God while many in our congregation & community seen and experienced the benefits it brought.

Our initial Capital Campaign pledge drive raised \$269,236.06 which ended February 1<sup>st</sup>, 2019. Along with other gifts and multiple donations, we have a current loan balance of \$292,899.94.

At our last quarterly voter's meeting, the voting assembly decided to begin a Capital Campaign to retire the narthex debt. This new campaign will extend over the next three years.

We have enclosed a capital campaign pledge sheet for you to fill out and return to the Expansion committee or Church office. We will be collecting your pledge forms in the back of church. You can also drop it off at the church office or email it. We ask that you keep this project in your prayers and that you would prayerfully consider sharing in this grace of giving. If you do not feel that you can make a three-year commitment, remember that any amount you can give will be used toward the debt retirement.

**What can I give to the Lord for all his benefits to me?** These are the words from Psalm 116 that we so often sing together in worship. God has certainly blessed all of us at St. John's. We see those benefits every time we are gathered together at church on Sunday and are fed with His Word & Sacrament. We certainly cannot repay the Lord for every benefit we receive. However, with gratitude in our hearts to God, we can work together to further His work among us here at St. John's.
