# **Hurricane Relief Efforts** and Souper Bowl!

As a new year dawns, we continue to remember those affected by the

devastating hurricanes and flooding last year.

St. Luke's is in the midst of collecting financial donations toward providing relief to victims of the hurricanes through NALC Disaster Relief. To date, about one-third of the \$5,000 goal has been collected. The donation drive is being extended to Easter. Financial donations collected on Souper Bowl Sunday in February as well as Lenten coin boxes will be applied toward the goal.

St. Luke's has also raised awareness through education and the collection of relief recovery items that was taken to the Mission District meeting in November. In addition, Pastor Keller and David McRandal will travel to Texas later this month as part of direct relief mission work in that area.

While financial donations on Souper Bowl will go toward disaster relief, the traditional collection of non-perishable canned goods will also take place. Items particularly needed are soup, pasta sauce, pasta, canned fruit and juice. More information will be coming.

Canned good items will be collected in the narthexes until Souper Bowl Sunday (2/4).
