General Orders:

Approval of Mission Goals: Approval of Mission Grants Randi Warneke passed out the Mission Grant Proposal Summary for 2022 based on last conventions budgeted amount and asked about keeping it the same or changing: Discussion held. Randi Warnke moved that the mission Grant budget be increased to \$110,000. Seconded and motion passed. Slate of mission grant proposals will be sent to groups to review with their delegates and voted on at convention. Linda Wills and Randi Warneke reports they had 14 scholarship applications that met criteria. ½ of these were first time applicants. Norma Hansen made the motion to fund all 14, dividing the scholarship monies equally. Motion seconded and motion carried.

Update for Convention: There will be an EC meeting 9:30am on Friday before convention. Sherry asked what the convention offerings would be for? Traditionally the morning offering goes to the mite mission fund. The afternoon offering goes to the missionary speaker. Since we will have two mission presentations Gary Thies, Mission Central and Cheryl Kees, Winnebago Preschool teacher. Margaret Morris made the motion to give the morning offerings to the mission grant goal and the afternoon offerings split 50/50 between Mission Central and Winnebago Preschool. Motion seconded a prayer by pastor Neidnow offered before voting, Motion passed.

Milwaukee Convention – Sherry reports she does not have a bus coordinator yet. The Arrow stage bus has been reserved and current plans are to start in Lincoln. Members riding the bus will need to arrange to be in Lincoln to board the bus. Sherry asked if there was interest in stopping at Mission Central on the way home? None expressed.

Sherry asked for a slogan – Pastor Niedow suggested "Motoring to Milwaukee". Slogan approved.

Sherry reports; Christal Miller is chairman for the Omaha Convention in 2025.

Retreat Committee Committee held first meeting today. Retreat: Dates: September 15-16 at Covenant Cedars bible camp. Theme will be "Feast in Comfort on God's Word". Bible verse: Psalm 119:76. **Let, I pray Your merciful kindness be for my comfort, According to Your word to Your servant.** Mission statement: "Allow participants to feast on God's word to take back to their group."
