I was having a conversation about what we were doing a year ago at this time, and it seemed more like 20 years ago since the COVID pandemic began.

While there is a light at the end of this long dark tunnel in the form of vaccines, this third surge we're experiencing now is worse than the two preceding waves, and the statistical modeling shows it will continue to be bad for the next month at least.

In November Bishop Julius Trimble held a Zoom meeting with all the clergy of the Indiana Conference and members of the Infectious Diseases Department of IU Medical Center—with whom the Bishop and Extended Cabinet are in constant communication. At that Zoom meeting Bishop Trimble strongly requested that all Indiana United Methodist Churches suspend in-person worship for the foreseeable future. Our Conference Superintendent, Mitch Gieselman sent out an email the next day reiterating to all of us in the Southwest District the Bishop's request. We complied.

On January 8 Bishop Trimble sent an email to all the clergy and leaders in our churches saying, "I believe it is to be the better part of wisdom to continue to not meet in person at your churches."

The Bishop's request was not a mandate because mandate implies punishment. It was, however, just shy of being a mandate for the good of our communities and the hospitals that are feeling the brunt of the burden of caring for COVID patients.

On January 11 The Ecumenical Consultation on Protocols for Worship, Fellowship, and Sacraments—a group made up of leaders from many denominations (including United Methodists) and health care professionals continued to recommend that churches not meet in person for the foreseeable future.

This group continued by saying "If any of the following are true for the county where you live, we recommend you do not meet indoors.

The number of new cases is rising.

ICU occupancy rates average above 80%

The Georgia Tech Risk Assessment Tool (which the Bishop and Cabinet use and encourage us to use as well) ranks your county above 40% likelihood for someone being present with COVID-19 at a 5 to 1 ascertainment bias.

Two days ago, as of this writing I gathered the most recent data for Vanderburgh County. The results are as follows:

Vanderburgh County is in the Red Zone with Weekly Cases per 100,000 Residents: 739 and a 7 Day Positivity Change of 22.1% with new cases on the rise.

ICU Occupancy Rate for Deaconess Hospitals is at 92% and Ascension is at 100%. That means if you or a member of your family needs an ICU bed *for any reason* they are nearly full or not available at our hospitals.

The Georgia Tech Risk Assessment Tool ranks Vanderburgh County in the following: In a group of 25 people there is a 75% probability that at least 1 person has COVID and in a group of 50 there's a 94% probability.

Right after Christmas our congregation had its first COVID death. The hospital chaplain called me in because it was an end-of-life situation (Currently all hospital patients can only have one visitor per day except in the COVID unit where no one is allowed in except at end-of-life).

I stood outside the patient's room and was able to look in through a glass in the door as a nurse held a phone to the patient's ear while I prayed the Ministry with the Dying (the United Methodist version of Last Rites) on the chaplain's phone.

Like you, I've heard the stories on the news about what hospital workers and patients are going through, but it's an entirely different experience to see it in person. While it was an honor to serve a member of this congregation this way, it's not an experience I'm eager to repeat.

This is a hard time. It's hard not to meet in our spaces. I don't like not meeting in person. No one does. But I believe we have a moral obligation not only to ourselves but to our community and the hospital staff to do all we can to mitigate the spread of this virus.

I believe our Bishop and Extended Cabinet are right in requesting we do not meet in person at this time and for the foreseeable future.

There is a light at the end of this dark tunnel. God will lead us through this time. As John Wesley said, "The best of all is God is with us!"


