

# The Spire

September 2020

It dawned on me the other day that I've spent half of my time since coming to Centenary in various forms of quarantine. About three months ago, we returned to in-person worship in the Family Life Center. It's been going fairly well, and attendance has crept up and almost doubled since we first returned. Nearly every week people who haven't been back before have come back, and we've even had first time guests.

Of course worship is different with everyone wearing masks, maintaining social distancing, and not singing as a congregation (we have had special music). Of course, we all want to be back in the sanctuary.

A group from the Trustees (Patrick McDonner, O.D. Putler, Andy Shepherd) met with Ben Kempf and me to review the precautions we'd need to take and the feasibility of returning to the sanctuary.

If we return to the sanctuary, we still would have to maintain social distancing, wear masks, and have no congregational singing as recommended by the CDC, the Indiana Conference, and the United Methodist Church. We would have to skip two rows of pews, seats would have to be marked to maintain not only six feet in the same pew but in front and behind as well. Ushers would have to escort persons to seats depending on the size of a family unit or group. The closest analogy would be like seating at a restaurant. People would not necessarily get to sit in "their" spot. And once a person or group was seated, there could be no changes due to keep the seat clean.

A chart was drawn up, seats were marked off, and T-shirts were placed in open seating to visualize what this would look like. A special section was set up to accommodate a bigger family.

It was determined the sanctuary could hold 50 people plus a large family. If all the larger seating areas would be taken, or more people would show up than we have space for, there would have to be some sort of overflow with logistic concerns at each overflow section.

With the soft surfaces in the sanctuary, cleaning would need to be enhanced. Bathroom usage would likely increase, which presents its own concerns, and there would be more areas for people to "drift" into—meaning more weekly cleaning.

One entrance would need to be used for entrancing, and another for exiting, and seating would need to be coordinated to prevent too many people gathering in the narthex. Also people would need to be dismissed by rows and led out the exit door. We would have to record who was sitting where in case contact tracing needed to be done in the event someone comes down with the virus.

A group is looking at the feasibility and cost of putting up plexiglass barriers of some sort, which would increase the number of people who could be in the sanctuary.

Air flow is another issue as this is an airborne virus. The airflow in the sanctuary isn't as efficient or as open as it is in the FLC creating another area of concern.

No one supported the idea of taking reservations for seating (as some churches are doing), and we currently do not have the means to take reservations smoothly.

The group decided that we don't gain anything by returning to the sanctuary, and we in fact lose flexibility of seating and numbers of people we can accommodate. So, it was decided we would stay in the FLC for the time being.

How long will this be? No one knows. We continue to monitor infection rates, the guidelines from the CDC, Conference, and General Church. We will return to the sanctuary as soon as we possibly can.

Until then, we're ahead of where we were three months ago by having the facility to safely have in-person worship. Many churches are still online only or have returned to online only as they've had infections occur in worship. Some churches are still meeting outside.

At the end of the day we have to remember the church is not a building; it's the people. Wherever worship happens is sacred space. We all long to return to as much "normalcy" as we can, but until the infection rate drops, treatment and testing increases, and a vaccine is found, we have to adapt a lot of our lives.

I am grateful beyond words to Patrick, O.D., Andy, Ben, and the rest of the Board of Trustees as well as other leaders of the church who have gone above and beyond to help us continue to have in-person worship and to make the decisions we've had to make and will make in the future.

We will get through this. Someday COVID-19 will be a memory. Until then, let us continue to follow the God who loves us and leads us through our wilderness into the Promised Land.




