Mr. Sternbach is Chief Technology Officer of Fusion Capital Management. This position consumes a fair amount of Mr. Sternbach's time and he is compensated accordingly, however this should not generate any conflict as the services he can provide to clients are the same as any other Investment Adviser Representative for Fusion.
