This is a summary of the annual report for INDIANA UNIVERSITY HEALTH BENEFIT PLAN, 35-1955872/550/Health, Life insurance, Accidental death & dismemberment (AD&D), Dental, Vision, Temporary disability, and Long-term disability for the period 1/1/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INDIANA UNIVERSITY HEALTH, INC. has committed itself to pay certain (Dental) claims incurred under the terms of the plan.

The plan has contracts with METROPOLITAN LIFE INSURANCE COMPANY, RELIANCE STANDARD LIFE INSURANCE COMPANY, EYEMED VISION CARE and NATIONAL UNION FIRE INSURANCE COMPANY OF PITTSBURGH, PA to pay certain (Health (other than dental/vision), Life insurance, AD&D, Vision, Temporary disability and Long-term disability) claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2018 were \$24,905,938.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes, if any, will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 340 WEST 10TH STREET, INDIANAPOLIS IN 46202 and at the US Department of Labor in Washington DC, or obtain a copy from the US Department of Labor upon payment of copying costs.
