General Rules and Regulations

Tuition

1. **Tuition is due on the first of each month.** There is a \$15.00 late charge added if tuition is received later than the 10th of each month.
2. There is a **\$5 discount on monthly tuition** when you sign up for automatic bank draft using your credit card or pay on or before the 1st of the month with check or cash.
3. **No registration fee** when pay for the full year's tuition in advance.
4. **Parents are responsible for monthly tuition August 2016 – July 2017 or until we are notified in writing that the student is dropping, regardless of attendance.** (*Dance only students until end of June 2017*)
5. **Please notify the office in writing at least 30 days in advance if your child is a drop.** If tuition becomes 2 months behind, your child will automatically be dropped and not allowed to attend class until the balance is paid. **In addition, your name may be reported to the credit bureau.**
6. There will be a \$25.00 fee on all returned checks.
7. **If your child's last name is different than your own, please write that on the bottom of your tuition check.**

Watching Classes

1. **No** parent coaching during class.
2. Parents and children are **not** allowed in the gym or dance rooms when there are no classes in progress.
3. **No** parents in the gym or in dance rooms during class time.

Dress Code

1. Children need to wear their hair pulled up for all classes.
2. Dancers must have a black leotard and pink tights.
3. Children need to have appropriate dance shoes in all dance classes.
4. Girls with black patent tap shoes must have elastic to replace the ties. **Put your child's name in all dance shoes.**
5. Tumbler and cheerleaders wear any color shorts and t-shirt/tank.
6. Gymnasts may wear any color **one piece** leotard (they should have bare legs and feet). Bike shorts are optional.
7. No jewelry, including rings in the gym.
8. We will not be responsible for any lost jewelry.
