****Please note:** Only the OFFICIAL meet entry form found in the Team Florida handbook and accompanying this packet will be accepted. No personal entry forms. The reason for this is that there has been important information left off, wrong entry fees paid and a host of other errors that cause delays and confusion. The official entry form has all correct information on it.

ALL ENTRIES MUST BE ACCOMPANIED BY ONE CLUB CHECK. Your entry will not be processed without full payment. It will not suffice to email an entry. It will be placed in a "do not process" file until full payment has been made.

LATE FEES: \$10.00 per athlete from Wednesday March 14 to Thursday, March 15
 \$20.00 per athlete from to Friday March 16-Sat March 17

Monday March 19 and after: **ENTRY DENIED**

(Team Florida does not want your money, what we need is properly filled out official entry forms with correct, full payment. If a check is sent that does not match up with number of entries and you have to send an additional check, you will be charged an additional \$10 for processing fee.

CHANGES TO ENTRY INFORMATION:

After deadline of Tues, Mar 12th, EACH change will be charged \$10.00. Example:

A name spelling change (\$10) and a level change (\$10) for a total of \$20. (Again, we don't want your money, we want you to check, double and triple check your entry before sending.) EXCEPTION TO THIS RULE: if you send your entry in before the deadline and you must change the highest all-around score due to athlete scoring higher in the third qualifier, you must notify Patti Gross via email by the deadline March 12th, and then you will not be charged a late fee. However, if you make the all-around score change after March 12th, you will be charged a \$10 late fee. OR if we discover through our records that your gymnast got a higher all around than what you sent in and we were not notified, we will make the change and your club will be assessed a \$10 per all around change fee. You have your own team; we have over 1,000 athletes to place appropriately. We need your cooperation.
